	in the format as indicated in the BoQ?

Q	What does the abbreviation CFP in the Volume 3 - Technical Specification, Book 4 - Structural, Volume
	1, 1.3 Bill Qty - item 39 refers to: "Galvanized CFP IPB160 length" or in the drawing for the bridge
	from the Main Structural Design, 52 pg: "CFP Ø 168.3 x 6".
A	The abbreviation CFP in the mentioned position stands for Cold Formed Profiles
Q	Given the time needed for clarification and solving the technical issues that were noted during the site
	visit performed on 21.12.2021., we are interested in whether the same may affect the extension of
	deadline for submitting tenders and whether you will reconsider the extension of deadline in that case.
A	The deadline for submitting tenders is extended in accordance with Corrigendum no 1.
Q	In the documentation for the construction of the first phase of the port in Virpazar BOOK 13 - MD of
	organization and technology_1 chapter 6. ESTIMATION OF DURATION OF WORKS The project
	provided 8.5 months for the construction of the first phase of the port in Virpazar. Is this deadline
	binding in the bid submission phase and the execution phase?
	Please clarify whether it will be possible to carry out works during the summer tourist season, since Virpazar is a tourist destination?
А	The project provided 8.5 months for execution phase.
A	All eventual restrictions in relation to the timeframe during execution phase will be notified and the
	execution phase fill be extended for the any days where execution of the works has been stopped
Q	At the meeting held on 21.21.2021. on the construction site of the future port in Virpazar, the Designer
×	stated that it will be possible and planned to deposit the excavation (position from the bill of quantities
	4. Wide excavation for the dock in the soil of II and III category with transport to the local landfill up
	to 2000m distance .) to the location planned for the construction of the second phase of the port in
	Virpazar. Please confirm this information. Also, it is planned that the material from the excavation in
	the lake will be tested, if the test results show that the material is contaminated and that it cannot be
	disposed of at the planned landfill, the question of a landfill of the same material is raised! Is the
	discovery of a new landfill and the possible additional cost, if it turns out by testing that the material is
	contaminated, the obligation of the Investor or the Contractor?

0	By visiting the field, we learned that there are plumbing and electrical installations within the

	located within the construction site of the first phase of the port in Virpazar, please provide it to us?

А	Considering all the questions concerning plumbing and electrical installations at the subject location the bidders will be informed in a timely manner.
0	The position of the works from the bill of quantities (Concreting of RC boxes types. The works
Q	include the production, transport and installation of concrete MB40, VDP8, MM100, with all
	preparations.) Is defined production, transport and installation. Please clarify the installation of RC
	boxes as well as the connection of the bottom plate reinforcement with the made RC boxes?
А	Reinforcement within the production of reinforced concrete boxes should be installed, and the amount
л	of armature and its design will be paid for and is provided through a special item.
Q	In the Bill of Quantities, the position is provided (Performing of embankment 1 from gravelly- sandy
Q	material with a maximum grain size of 65mm. The embankment is formed in layers up to 40cm thick
	and compacted to the compressibility modulus $Ms = 30MPa$ to the last layer, the last layer is
	compacted to the compressionity modulus $Ms = 30MPa$ .) Please confirm that it is possible to use
	the material from the quarry and provide us with the required technical characteristics
А	The excavated material cannot be used for embankments because it is muddy and contains a lot of
	organic matter. Gravelly sandy material is used for the embankment, well graduated (river or crushed
	stone) whose characteristics are not affected by water for more than 3% reduction in strength
Q	Can Investor submit the tender documentation in the Montenegrin language to the potential bidder?
A	The official language of this tender is English
Q	In the Contract Notice Document, in the Chapter "Selection Criteria", paragraph "Technical and
	Professional Capacity of Candidate", where is stated: "The tenderer or a lead member of consortium
	must be in possession of license for related work in line with Law on Spatial Planning and Construction
	of Montenegro". This creates to us the opinion that any Bidder who wants to submit the tender for the
	above tender procedure, should have this license according the respective Law as applicable in
	Montenegro, prior the tender submission;
	Meanwhile, if we see beyond, in the further tender requirements, regarding the possession of Licenses,
	in accordance with the Montenegrin Legal Framework, is stated:
	"Note: At the moment of tender submission, the Tenderer must be accredited and registered for such
	type of activity by the national accreditation authorities of his country.
	At the moment of Contract signing, the Contractor will have to be accredited (authorized), registered
	and he (including his personnel) shall have all professional licenses, necessary for the execution of the
	contracted Works, in accordance with the relevant legislation of Montenegro.
	License for execution of works, issued by the relevant Ministry in accordance with the Law on Spatial
	Planning and Construction of Facilities Art. 122, 123, 193 ("Official Gazette of Montenegro", No.
	064/17 from 06.10.2017, 044/18 from 06.07.2018, 063/18 from 28.09.2018, 011/19 from 19.02.2019,
	082/20 from 06.08.2020)".

Q	Our Company has in possession the required License to perform such Works, issued from the respective
	Authorities in the Country of Origin, which satisfies the above tender requirement: " Note: At the
	moment of tender submission, the Tenderer must be accredited and registered for such type of activity
	by the national accreditation authorities of his county";
	Also, in case of being awarded, and prior of the Signature of the Contract, we intend to fulfill the above
	mentioned requirement, for the provision and validation of all the required Licenses, in accordance with
	the Montenegrin Legal Framework, including those for the Specific Engineer, as stated in above: "At
	the moment of Contract signing, the Contractor will have to be accredited (authorized), registered and
	he (including his personnel) shall have all professional licenses, necessary for the execution of the
	contracted Works, in accordance with the relevant legislation of Montenegro";
	Considering the definitions of the above different paragraphs of the requirements on Licenses for the
	execution of such works, are we considered compliant, if during the tendering stage we submit our licenses as are issued in the Country of Origin, including the technical Staff, and in case of being
