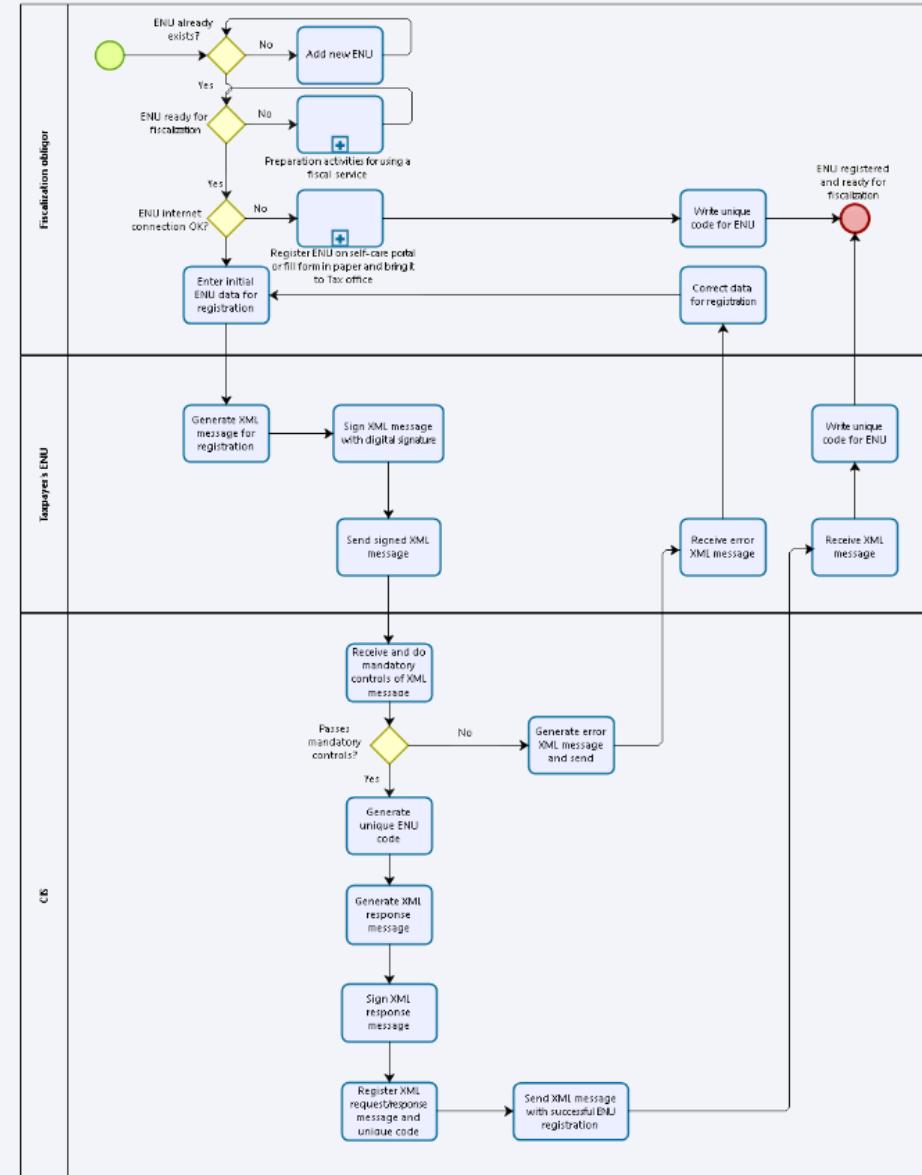

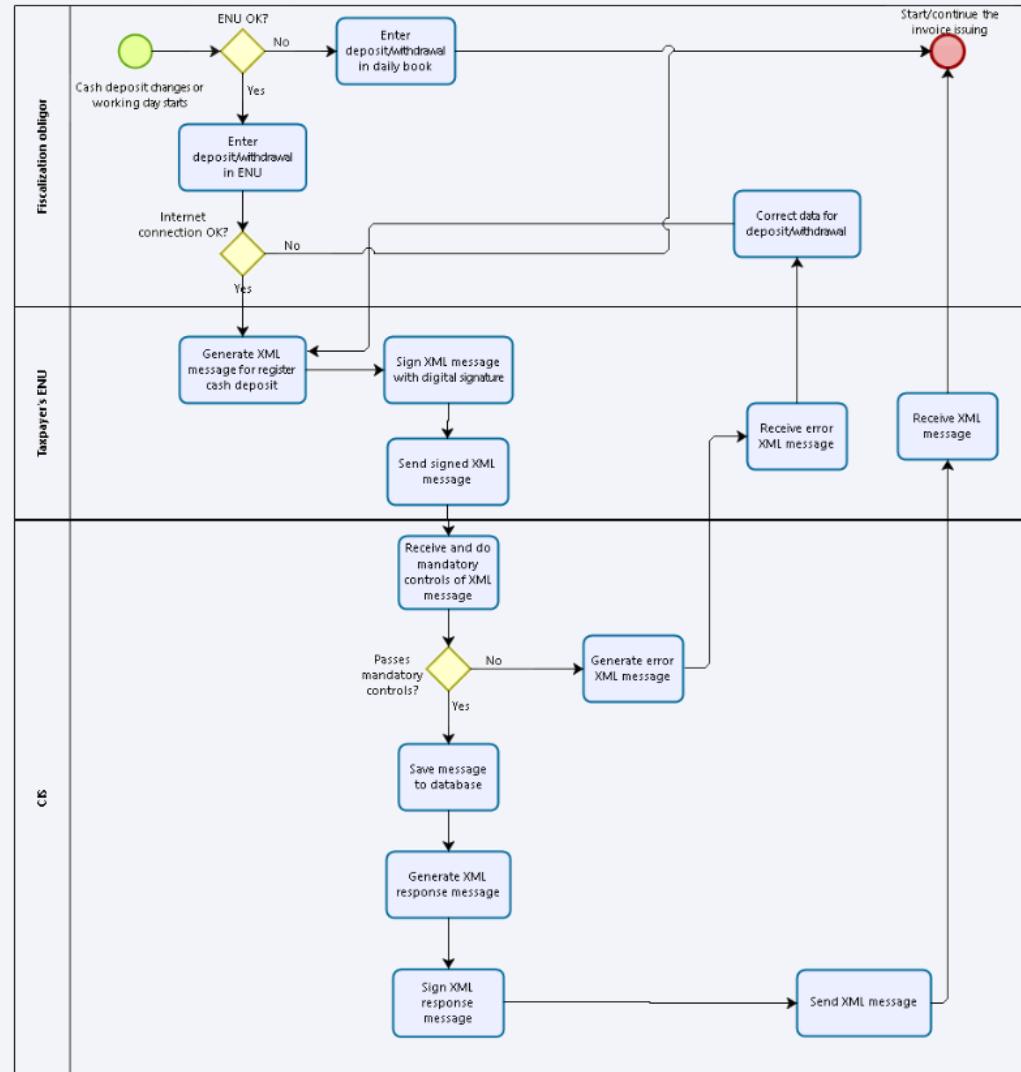

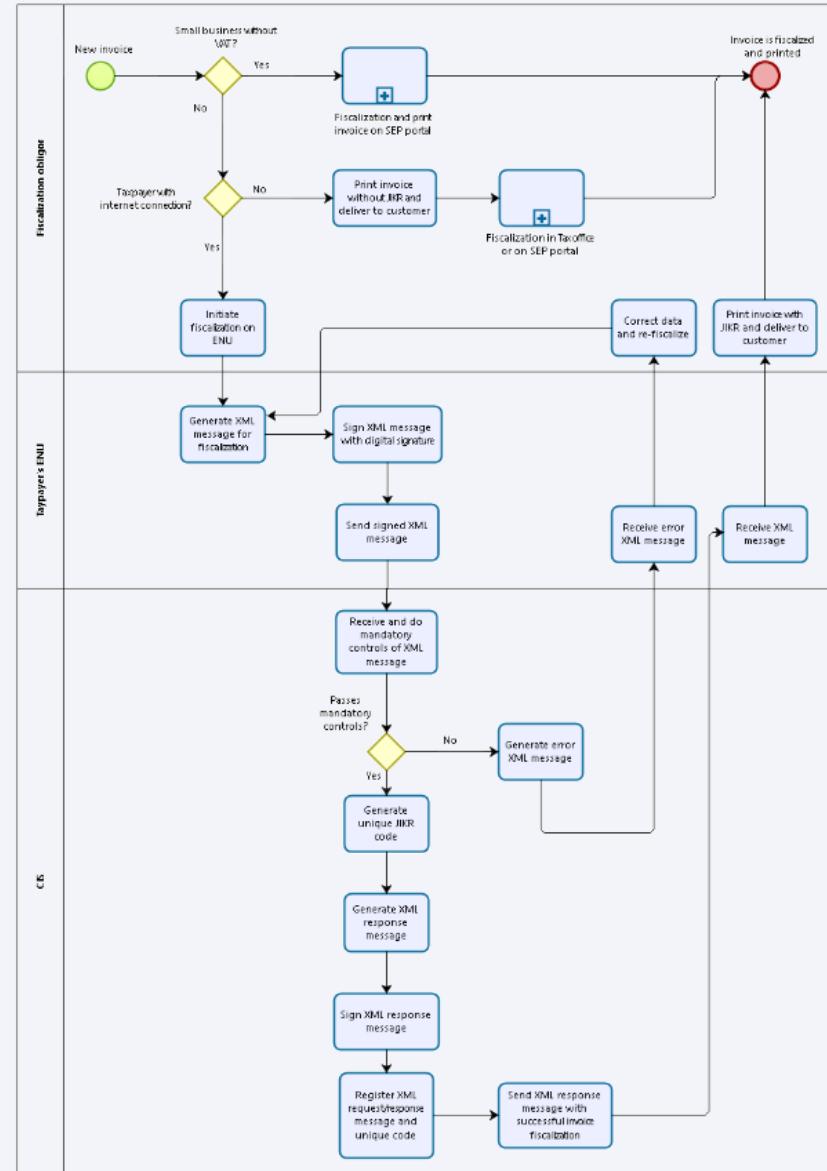

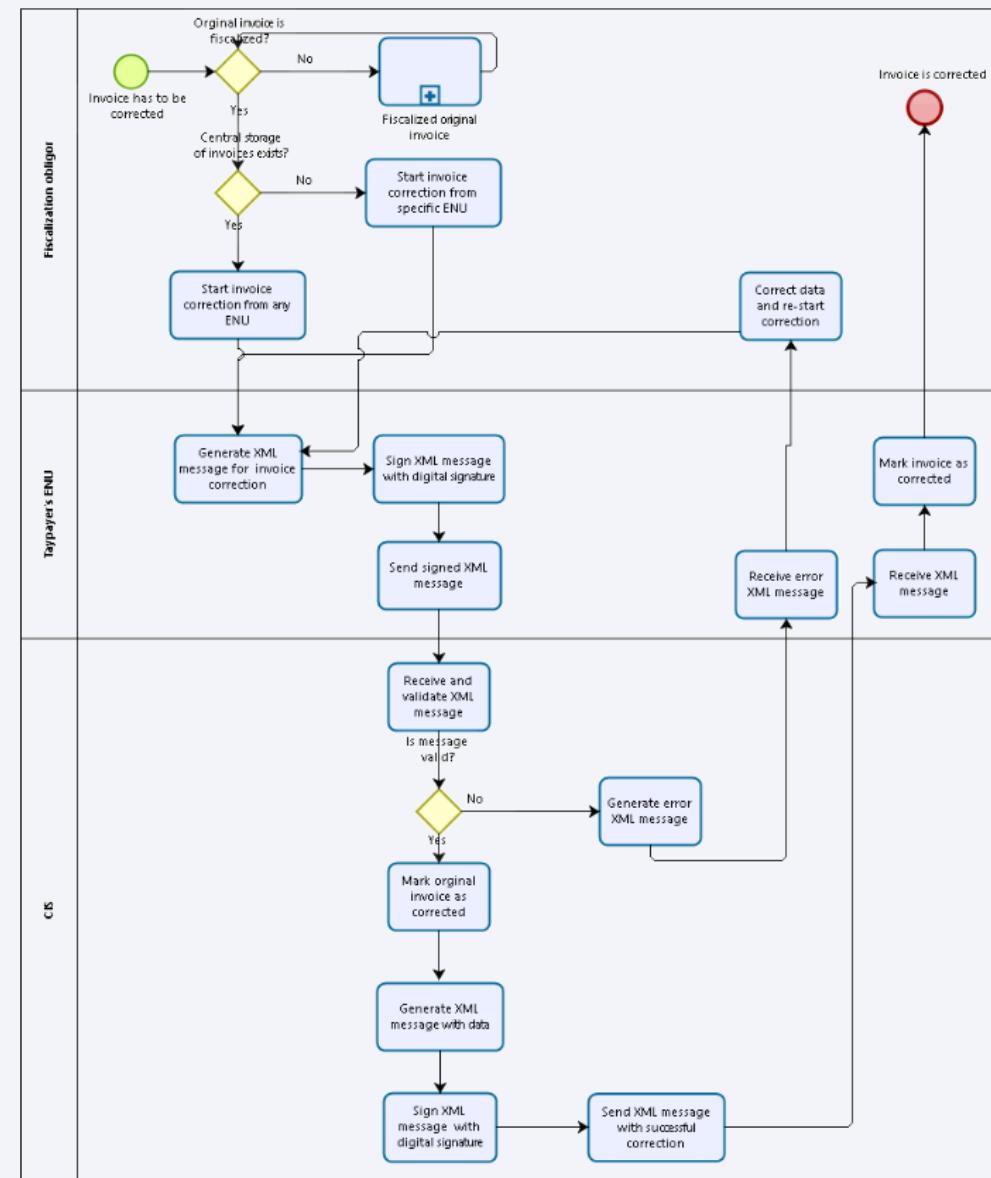

5. Printing invoice with QR code

- QR code must be printed on all invoices, fiscalized or not
- Data stored in QR code:
 - PIB of the taxpayer
 - Date and time of issuing invoice
 - Number of the invoice
 - Code of business premise
 - Code of the ENU
 - Code of the software
 - Total invoice amount

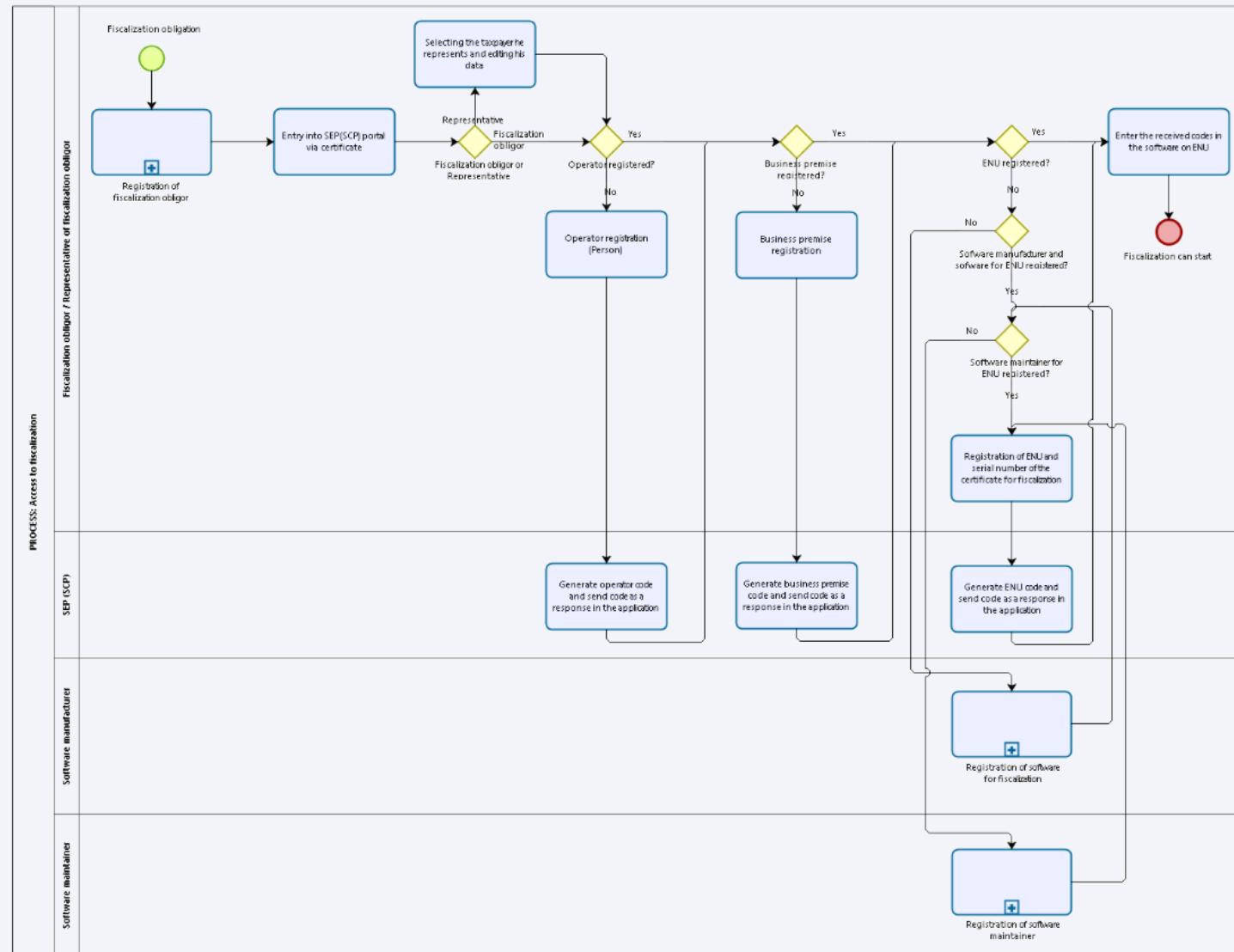

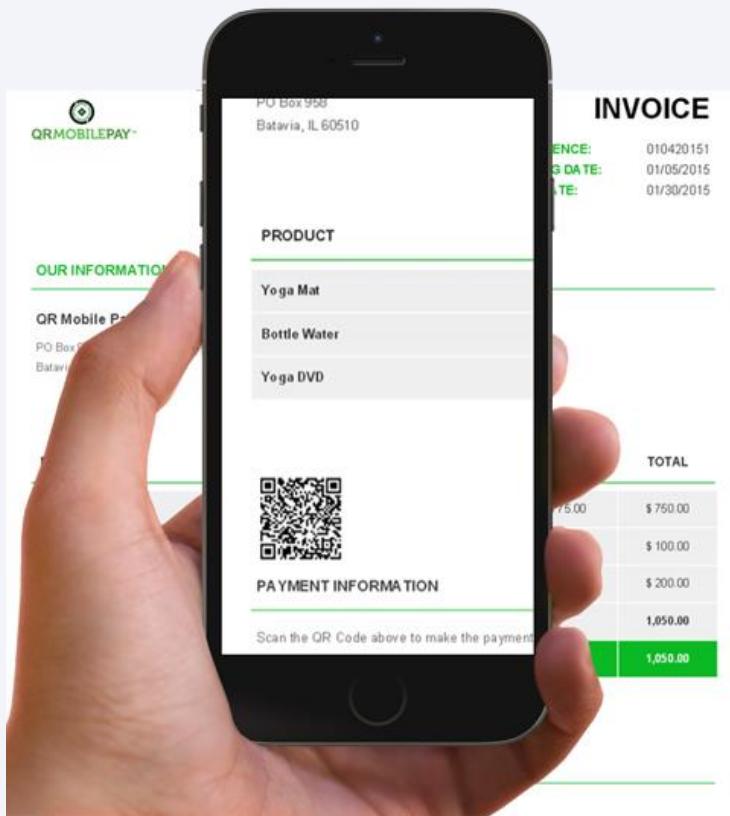

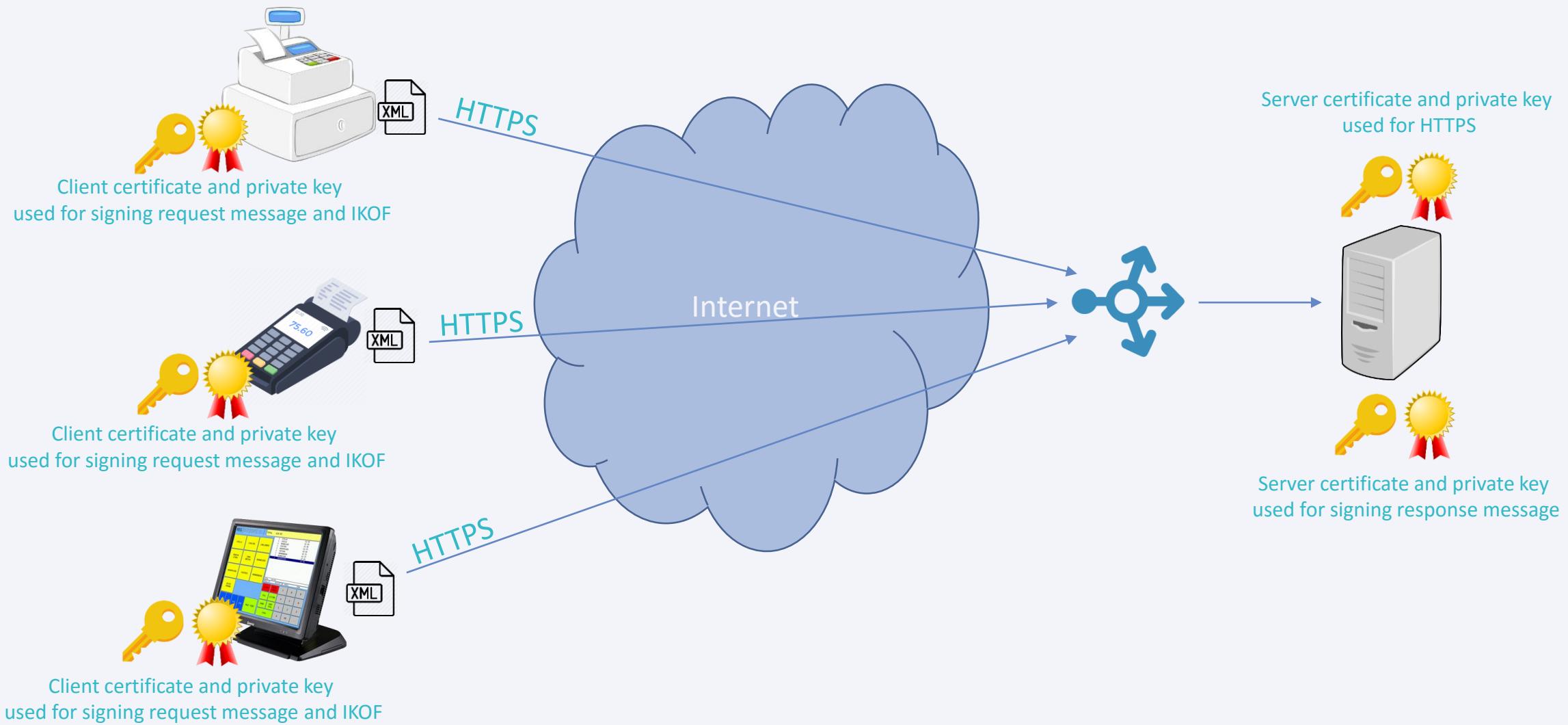

XML response with data located on a printed receipt. Data includes JIKR (FIC - Fiscalization Identification Code)

IKOF from a outgoing message and JIKR from incoming message must be printed on the receipt.

XML signature of the reseponse data with certificate of the fiscalization service.
