## Question 1:

#### Answer 1:

Answer 2: All unit prices must be stated without VAT, and consequently the Contract price shall be stated without Vat. The procedure for exemption of contractors from VAT is given in the Official Gazette of Montenegro (No. 68/15).

Question 3: Please provide an information on the designers and auditors in the project.

Answer 3: This information cannot be made available at this stage in order to preserve the confidentiality of certain elements of the main design documentation. The tender dossier already constitutes required elements as to allow the tenderers to prepare responsive offers.

Question 4: In the Volume 1, ITT, Clause 12.1.9. is written:" The tenderer must take account of weather conditions and the requirement to prepare designs and obtain building permits prior to carrying out construction works." This sentence is a little bit confusing. According to Montenegrin law, the building permit and designs shall be submitted to the Contractor by the Contracting Authority. Please, could you clarify will the Contracting Authority provide the building permit and designs to the Contractor?

Answer 4: We confirm that the Contracting Authority will provide to the selected Contractor the full set of Main Design for adaptation and reconstruction of the cross-border railway station in Bijelo Polje, as well as relevant building permit and/or the notification of building work pursuant to the Montenegrin Law.
