### **o potpisivanju Aranžmana o dijeljenju troškova sponzorskih nacija za NATO Centar izvrsnosti za kooperativnu sajber odbranu**

NATO Centar izvrsnosti za kooperativnu sajber odbranu (Centar) je osnovan od strane sedam država, i to: Republike Estonije, Savezne Republike Njemačke, Republike Italije, Republike Letonije, Republike Litvanije, Republike Slovačke i Kraljevine Španije, koje su potpisale Memorandum o razumijevanju o funkcionalnom odnosu, 14. maja 2008. godine. Iste godine Centar je akreditovan od strane Sjevernoatlantskog savjeta (NAC).

Misija Centra je da ojača kapacitete za kooperativnu sajber odbranu, kako NATO-a, tako i samih NATO članica, u cilju unapređenja interoperabilnosti na ovom planu, ali ne predstavlja dio NATO vojne strukture, niti NATO strukture snaga. Takođe, pruža podršku svojim članicama i NATO-u u oblasti sajber odbrane kroz multidisciplinarna primijenjena istraživanja, ekspertska savjetovanja, obuke i vježbe. Četiri glavna polja djelovanja ovog obrazovno-istraživačkog centra na planu sajber bezbjednosti su: tehnologije, strategije, operacije i pravo.

Crna Gora je nakon sprovedenog procesa pridruživanja od 9. juna 2020. godine postala članica Centra, sa statusom sponzorske nacije, u skladu sa Memorandumom o razumijevanju o funkcionalnom odnosu i Memorandumom o razumijevanju u vezi sa osnivanjem, upravljanjem i radom.

U skladu sa Memorandumom o razumijevanju u vezi sa osnivanjem, upravljanjem i radom Centra, Sekcijom 7 su definisane obaveze u pogledu budžeta i dijeljenja troškova za rad Centra. Podjela troškova je bazirana na Aranžmanu o dijeljenju troškova sponzorskih nacija, gdje je tačkom 7.2 definisan način podjele troškova za svaku fiskalnu godinu. Navedena podjela troškova se izračunava po sljedećem:

$$\frac{\text{broj pozicija sponzorske nacije u Centru}}{\text{ukupan broj radnih pozicija u Centru}} \times \text{ukupan budžet Centra}$$

Iznos sredstava koji je potrebno izdvojiti za 2021. godinu je 23.000 eura, a isti je planiran predlogom budžeta za 2021. godinu.
