

## Fees for inscription into Montenegro Yacht Register

Fees for registration, renewal of registration and deletion from the Register  
("Official Gazette of the Montenegro", No. 42/15)

For inscription of the yacht in the register and renewing of the Certificate the fee shall be paid amounting to:

- 1) € **30.00** per meter length for the motor driven yacht and multi-hull yacht;
- 2) € **20.00** per meter length for the sailing yacht.

For deletion of the yacht from the Register the fee amounting to € **20.00** shall be paid.

### Technical Survey of the yacht

("Official Gazette of the Montenegro", No. 42/15)

For initial and periodical survey the fee amounting to € **7.00** shall be paid per meter length of the yacht.

For occasional survey the fee shall be paid in amount of **20%** of the price of inscription of the yacht.

**Administrative fee** -The decision on the allocation of MMSI number and call sign

### Taxes on the use of vessels

Taxes on the use of vessels is reduced by 5% for each year of age of the vessel, provided that the total reduction may not exceed 50% of the prescribed amount of tax.
