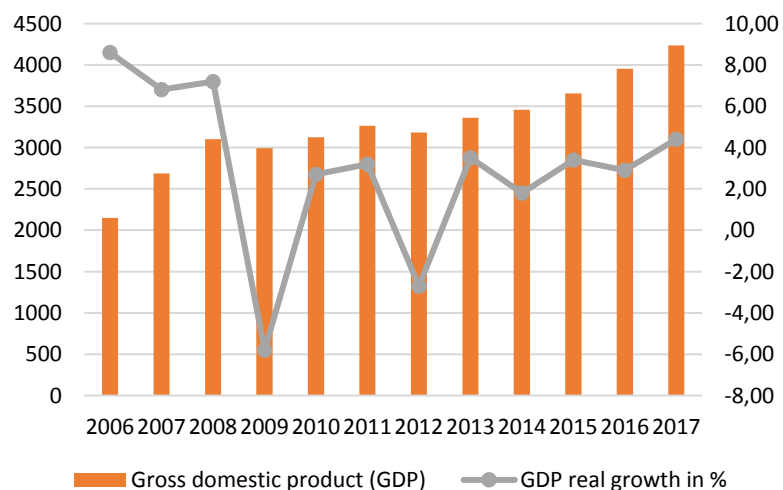

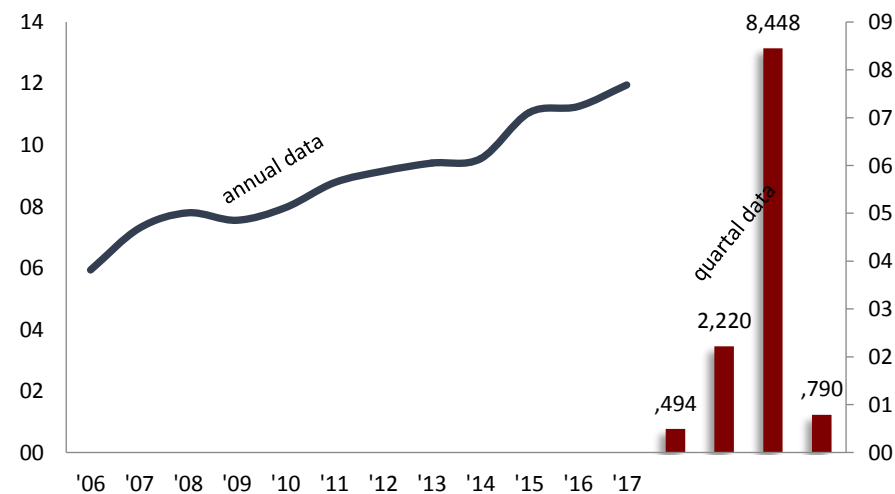

Graphic 2 Tourism overnight stays, in mill. €

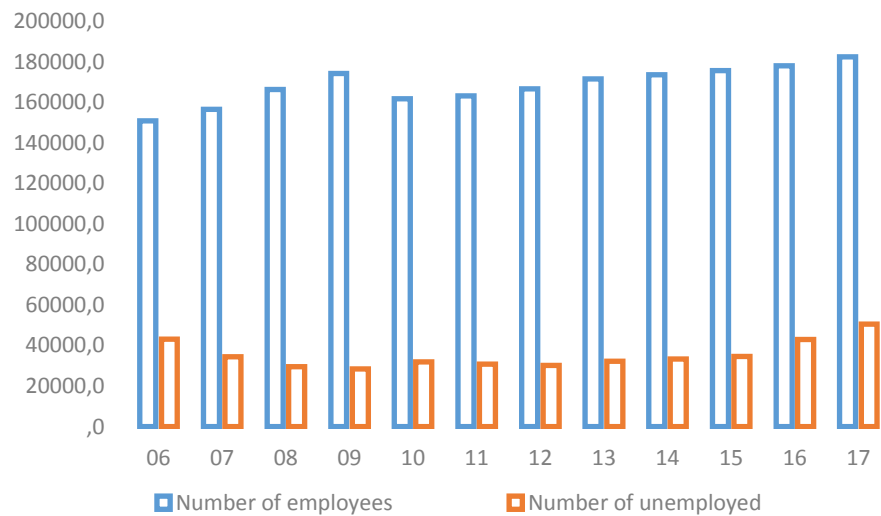

Graphic 4 Wages and pensions trend in €

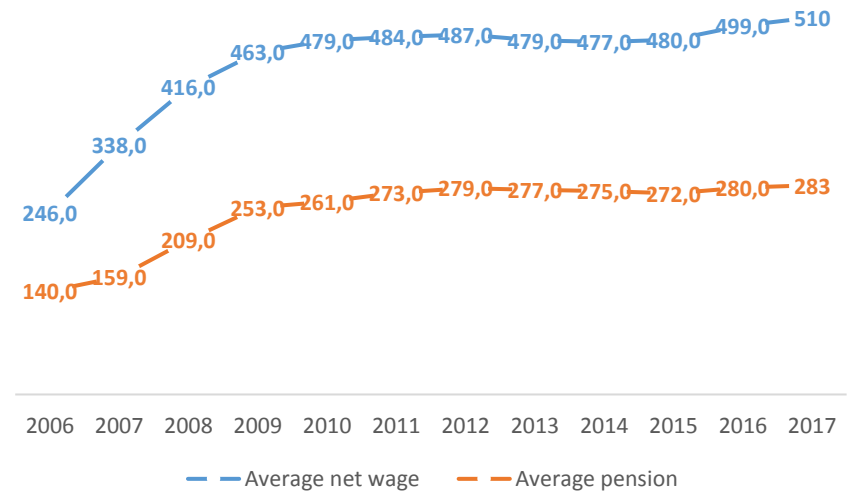
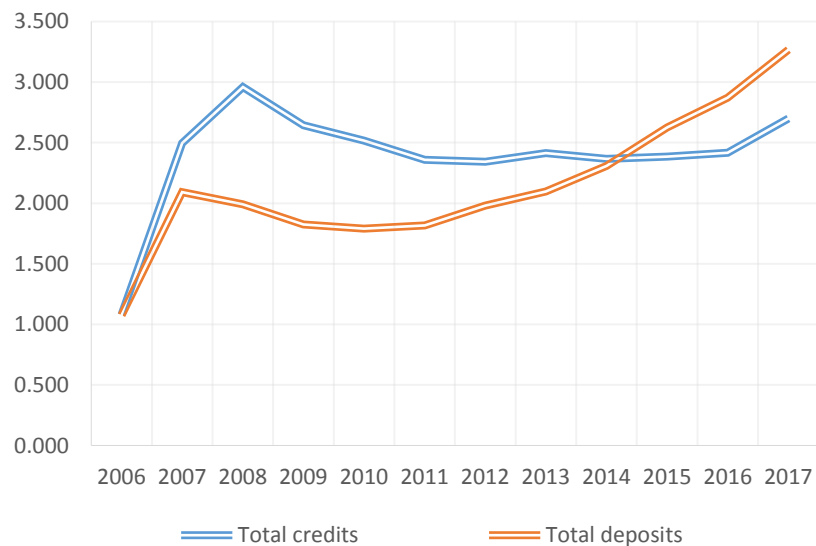

Graphic 6 Interest rates trend in %

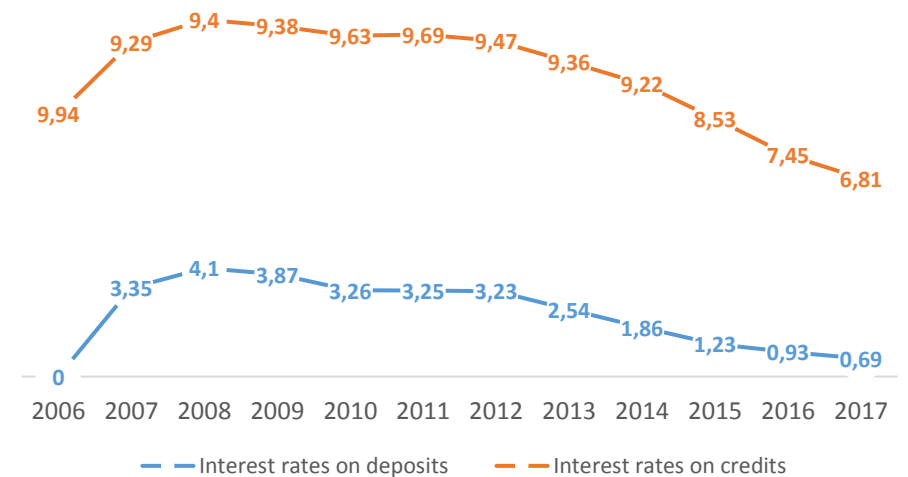
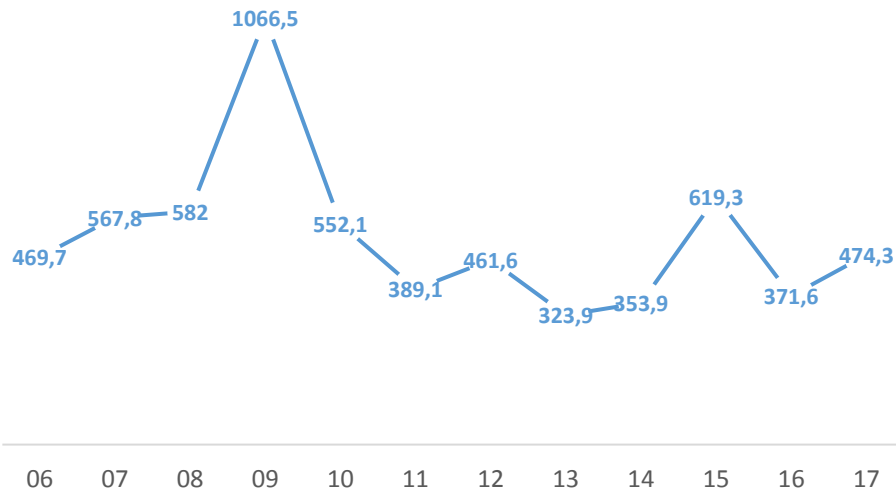


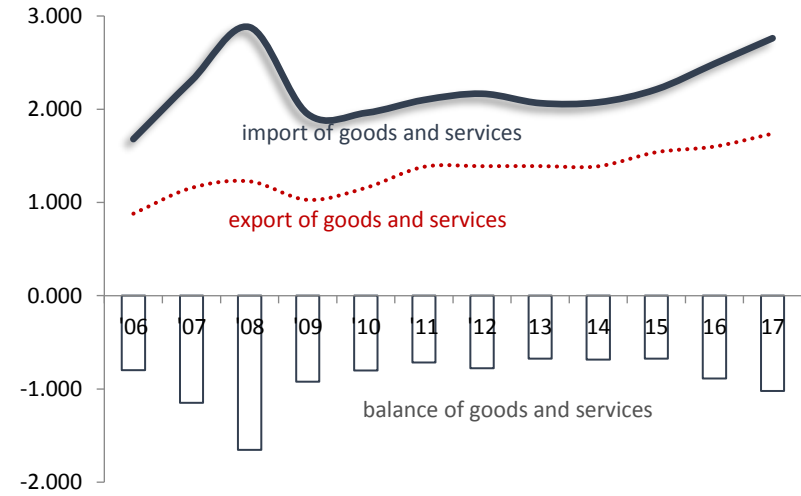

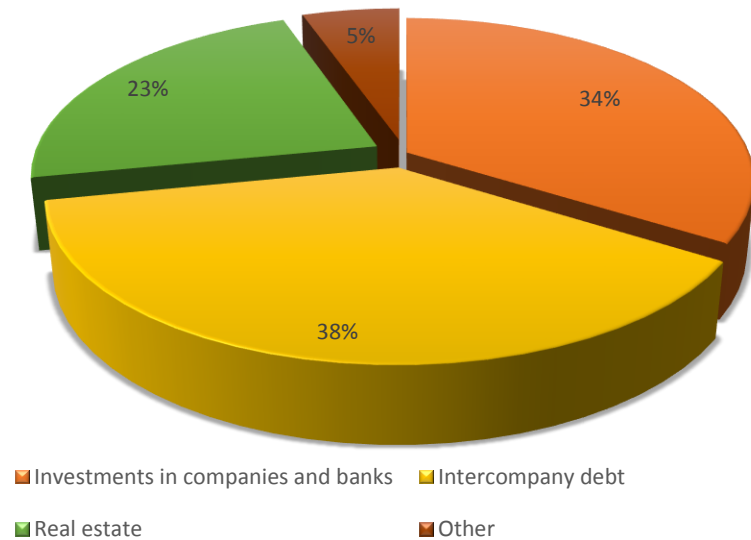
Graphic 7 Net FDI trend in mill. €

Graphic 10 Export of services trend in mill. €

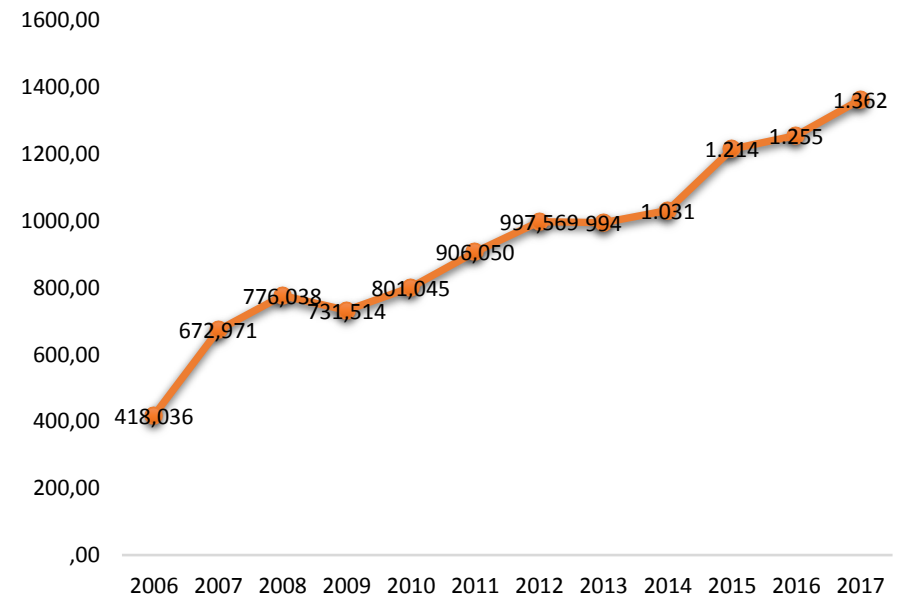

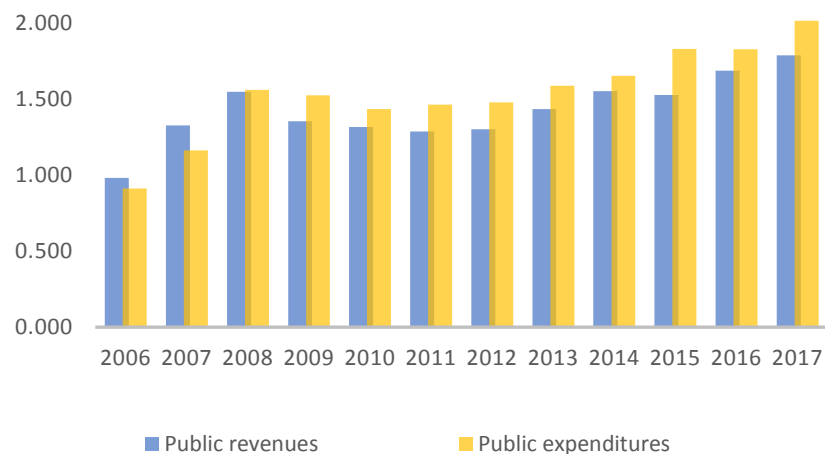

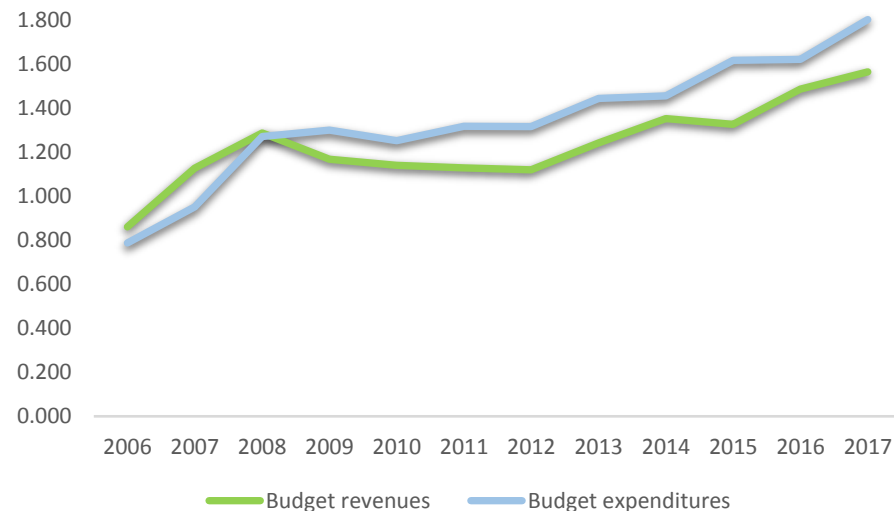

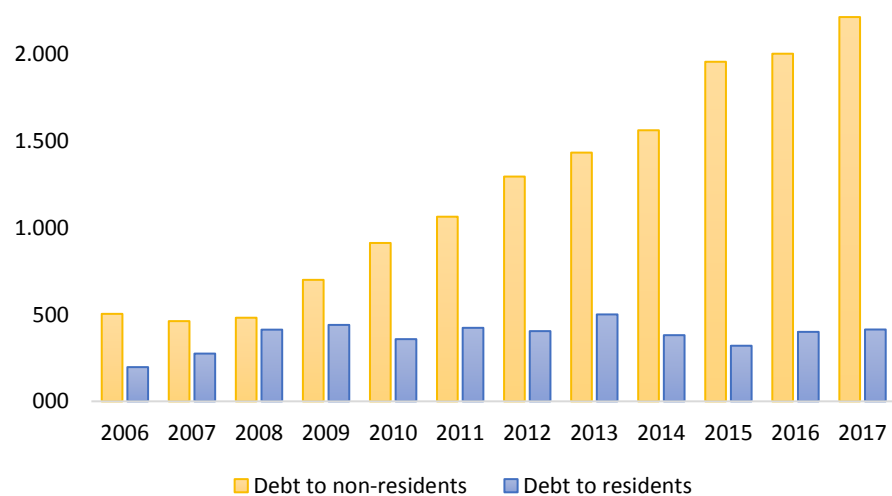
Graphic 11 Public revenues and public expenditures trend in mill. €

Graphic 14 Guarantees trend in mill. €

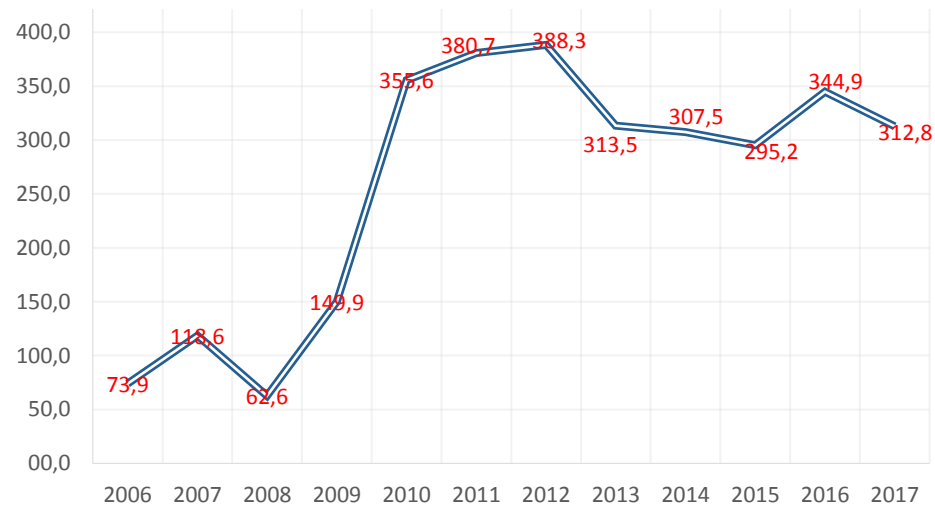
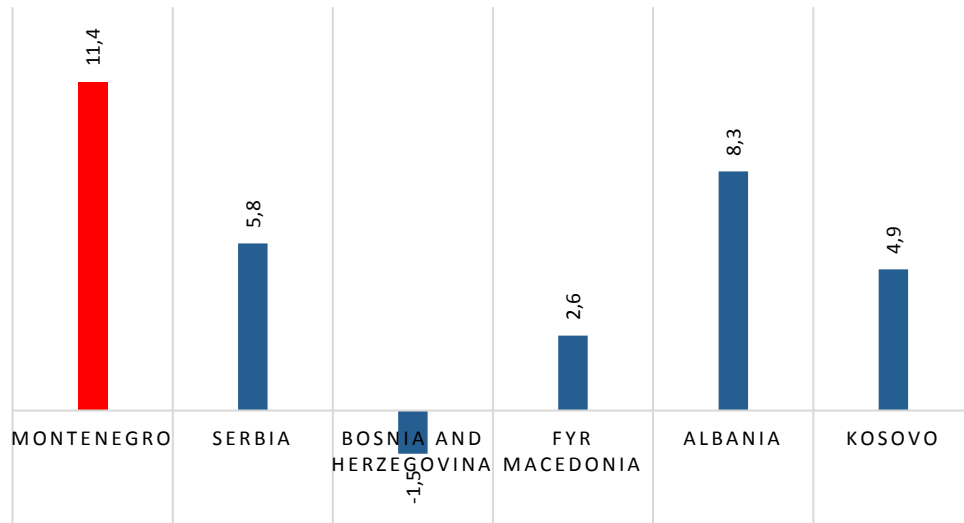


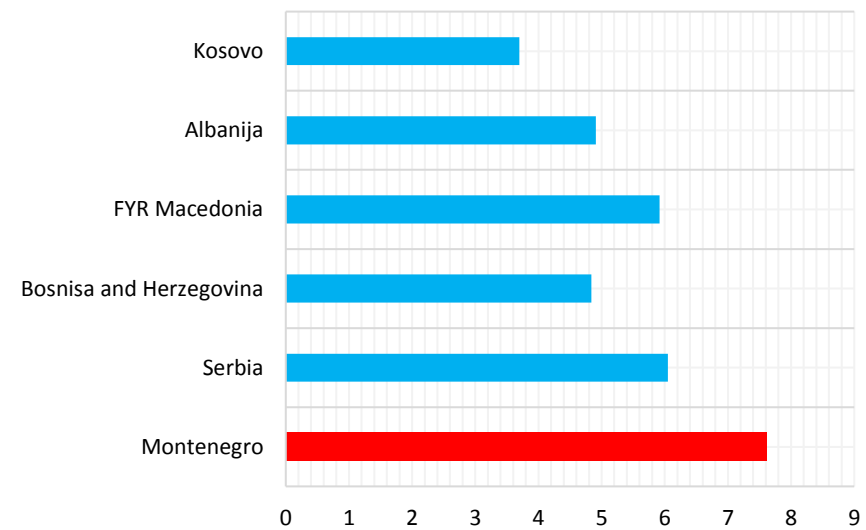

Graphic 16 GDP per capita, nominal in .000 US \$



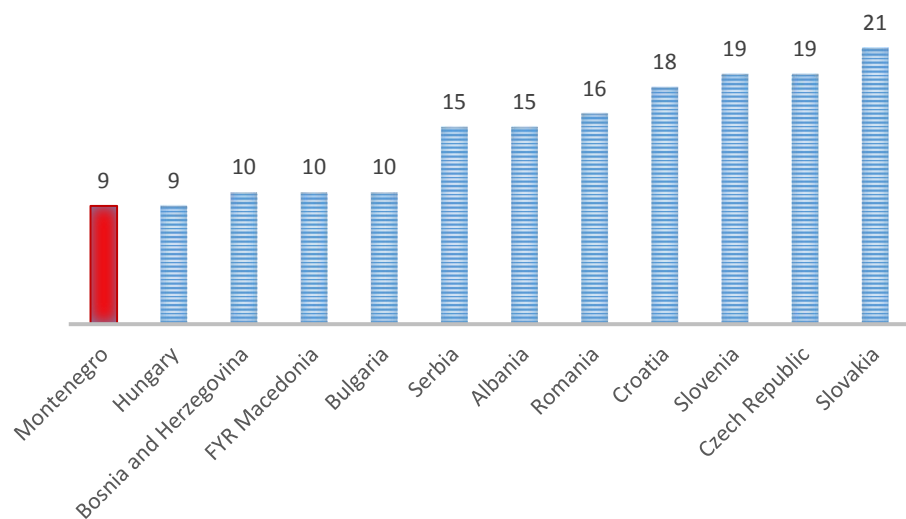
