o predlogu Amandmana broj 3 na Memorandum o razumijevanju koji se odnosi na multinacionalnu saradnju po pitanju obezbjeđenja odlučujuće municije za kopnenu borbu, u cilju pristupanja Ministarstva nacionalne odbrane Rumunije Memorandumu

Ministarstvo nacionalne odbrane Rumunije je u junu 2022. godine uputilo zahtjev za prijem u članstvo NATO LBDM inicijative, koje će se omogućiti Amandmanom br. 3 (u daljem tekstu: Amandman) na Memorandum o razumijevanju (u daljem tekstu: Memorandum) koji se odnosi na multinacionalnu saradnju po pitanju obezbjeđenja odlučujuće municije za kopnenu borbu (*Land Battle Decisive Munition*, skraćeno: LBDM, u prevodu na crnogorski jezik: Odlučujuća municija za kopnenu borbu, u daljem tekstu: odlučujuća municija).

Odlučujuća municija je NATO termin koji podrazumijeva municiju velikog kalibra, raketna sredstva kao i druge vrste ubojnih sredstava kopnene vojske koja zbog svog značajnog dejstva mogu odlučujuće uticati na ishod borbi.

Amandman će biti potpisan od strane ovlašćenih predstavnika svih zemalja-članica Inicijative, kao i Rumunije kao nove članice.

Pristupanjem Crne Gore 2018. godine Memorandumu uspostavljena je osnova za međusobnu saradnju u nabavkama, održavanju i skladištenju municije između država potpisnica. Ovom inicijativom je obezbijedena zajednička nabavka odlučujuće municije u skladu sa važećim propisima o nabavkama, prenos i razmjena kapaciteta odlučujuće municije kao i aktivnosti u vezi sa multinacionalnim upravljanjem životnim ciklusom odlučujuće municije, uključujući i neutralizaciju putem delaboracije.

Ministarstvo odbrane Kraljevine Belgije je vodeća zemlja ove inicijative, u kojoj za sada učestvuju još 22 zemlje-potpisnice, uključujući Crnu Goru.

Crna Gora nema finansijskih obaveza iz budžetskih sredstava Crne Gore, kako po pitanju aktivnosti u okviru LBDM inicijative, tako i po pitanju pristupanja bilo koje nove članice, što se odnosi i na pristupanje istoj od strane Ministarstva nacionalne odbrane Rumunije.

2.3 All other provisions of the LBDM MoU remain unchanged.

SECTION 3

FINAL PROVISIONS

3.1 Pursuant to Section 12 (Admission of new Participants) and Section 14 (Amendment) of the LBDM MoU, this Amendment n°3 to the LBDM MoU will enter into effect when signed by all the existing Participants and the new Participant.

31 This Amendment n°3 to the LBDM MoU will remain in effect as long as the LBDM MoU it amends.

3.3 This Amendment n°3 to the LBDM MoU is signed in the English and French language, each text being equally valid. The originals of this Amendment n°3 will be kept with the Belgian Participant, which will transmit certified copies to each of the Participants.
