## **2022 WTO VIRTUAL EXECUTIVE TRADE COURSE (in English)\* 14 February – 8 April 2022**

### **Invitation to present candidates**

The Institute for Training and Technical Cooperation of the World Trade Organization (WTO) is organizing the second WTO Virtual Executive Trade Course in English, to be held from Monday 14 February to Friday 8 April 2022.

The purpose of the Virtual Executive Trade Course is to present current issues of interest to the WTO Membership aimed at increasing the understanding on these topics as well as encouraging critical thinking to explore the linkages between WTO rules and disciplines and countries' trade policies and interests in the multilateral trading system.

The Virtual Executive Trade Course will be organized in seven modules, each one taking place during a specific calendar week and dealing with a different WTO topic. For each module, an initial session will be made available to registered participants at the beginning of the relevant week. Some modules may include an additional session, such as Q&As and/or a roundtable discussion, organized towards the end of the week in question. Each session will last 90-120 minutes. A tentative programme is attached to this invitation. Sessions may be transmitted live or made available through a pre-recorded video. Due to possible time differences among participants, and to allow flexibility to participants, the sessions will remain available for a period of two consecutive calendar days so that participants may view them at a convenient time. Once registered, participants will have the option of attending the whole course or one or more specific sessions, according to their interest and availability.

The course is targeted at Senior Government Officials who are directly involved in WTO-related work and who already possess a deep knowledge of the general features of the WTO system and the WTO Agreements.

The Governments of Members and Observers to the WTO, which are eligible to benefit from training and technical cooperation activities, are invited to present candidates to participate in this course. Eligible candidates must have relevant and substantial professional knowledge or experience. They must also possess an excellent ability to communicate in English both orally and in writing. **Up to 60 participants** may be selected by the WTO Secretariat to participate in this activity.


