**u vezi sa potpisivanjem nota o pristupanju Ministarstva vanjskih poslova Islanda Memorandumu o razumijevanju u vezi sa funkcionalnim odnosom u NATO Centru izvrsnosti za kooperativnu sajber odbranu, odnosno Memorandumu o razumijevanju u vezi sa osnivanjem, upravljanjem i radom NATO Centra izvrsnosti za kooperativnu sajber odbranu**

Ministarstvo odbrane, odnosno Crna Gora je od 9. juna 2020. godine postala članica NATO Centra izvrsnosti za kooperativnu sajber odbranu u Estoniji (CCD COE), sa statusom sponzorske nacije, u skladu sa Memorandumom o razumijevanju u vezi sa funkcionalnim odnosom i Memorandumom o razumijevanju u vezi sa osnivanjem, upravljanjem i radom. CCD COE je dio šireg okvira za podršku aranžmanima NATO komande, ali on ne predstavlja dio NATO komandne strukture. Koordinaciju rada CCD COE vrši NATO Štab vrhovnog komandanta Savezničke komande za transformaciju.

Proces pridruživanja je podrazumijevao potpisivanje nota o pristupanju Memorandumu o razumijevanju u vezi sa funkcionalnim odnosom u CCD COE i Memorandumu o razumijevanju u vezi sa osnivanjem, upravljanjem i radom CCD COE, od strane svih članica CCD COE, nakon čega je Ministarstvo odbrane i zvanično postala sponzorska nacija u okviru ove organizacije.

Ministarstvo odbrane je posredstvom predstavnika CCD COE informisano da je Ministarstvo vanjskih poslova Islanda izrazilo namjeru da se pridruži CCD COE i da, kao sponzorska nacija, doprinese radu ovog centra.

S obzirom na proceduru pristupanja, od strane CCD COE je dostavljen zahtjev za potpisivanje nota o pristupanju Ministarstva vanjskih poslova Islanda Memorandumu o razumijevanju u vezi sa funkcionalnim odnosom u NATO CCD COE, odnosno Memorandumu o razumijevanju u vezi sa osnivanjem, upravljanjem i radom NATO CCD COE.

Kako koordinaciju rada CCD COE vrši NATO Štab vrhovnog komandanta Savezničke komande za transformaciju, note o pristupanju Ministarstva vanjskih poslova Islanda predmetnim memorandumima će potpisati nacionalni predstavnik Crne Gore u Savezničkoj komandi za transformaciju.
