Based on the Sub-clause 4.4 of Design and Build Contract of Bar-Boljare highway, priority section Smokovac-Uvac-Matasevo, reference no. 01-827/1 dated 26 February 2014 (Official Gazette of Montenegro, no. 54/14), Ministry of Transport and Maritime Affairs, as the Employer issued:

**PRIOR CONSENT no. 13**  
for subcontracting

At the request of the Contractor No. CRBC(MNE-MTP)/PC/171/2015 dated 17.07.2015., and its amendments No. CRBC(MNE-MTP)/PC/171-2/2015 dated 21.07.2015. and No. CRBC(MNE-MTP)/PC/185/2015 dated 24.07.2015., it is giving the Prior Consent for hiring subcontractor **CIJEVNA KOMERC d.o.o.** Podgorica, for the execution works on concrete mixing, transportation and pumping, and heating and thermal insulation in winters within left line LK 25+795.32-LK 30+612.16 and right line RK 25+876.68-RK 30+664.305.

Within seven (7) days prior to the start of work of the Subcontractor, the Contractor shall submit to the Engineer an appropriate document on the subject, value and duration of the subcontracting agreement. This document must be signed and stamped by the Contractor and the Subcontractor. If it does not act in this way, this Consent shall be repealed.

The documentation on registration, suitability and experience of the Subcontractor represents the basis and an integral part of the Prior Consent.
