The Programme is to be implemented in a time frame of approx. 4.5 years. The Programme builds on the previous phase (EEPPB Phase I). In the framework of EEPPB Phase I 30 educational facilities were selected on the basis of economic, technical and ecological criteria and 21 of them have or will be retrofitted between 2013 and 2015. The remaining 9 educational facilities that were preselected by the EEPPB Phase I and for which energy audits and investment packages exist, shall also be considered in this Programme Phase II. For the remaining facilities (as stated above) preliminary energy audits with identification of investment packages are being performed by a separate structural and energy consultant. He will short-list the buildings together with the Project Coordination Board (PCB). The structural and energy audits and the identified investment packages will serve the Consultant as base for his implementation concept and design works. The supply and works contracts shall be tendered internationally to general contractors for regional clusters of approx. 3-7 buildings each (based

Required Consulting Services:

The Consultant shall strengthen the Ministries' professional competence regarding effective and efficient programme implementation and assist them in the implementation of the Programme. The consulting team shall comprise of international and local experts and is to be headed by a Team Leader with substantial experience in the energy efficient rehabilitation of public or commercial buildings (preferably schools). A sufficient number of experienced and qualified site-supervisors is required because a thorough construction supervision in order to ensure high quality standards of workmanship is a key element of the Programme. The position of the Energy Advisor should be covered by an experience expert with a long track record in energy management and operation of buildings. Consulting team shall also include qualified auditors, led by experienced Energy Efficiency Expert.
