Considering the Memorandum of Understanding among the Federal Minister of Defence of the Republic of Austria, the Minister of Defence of the Kingdom of Belgium, the Ministry of Defence of Denmark, the Ministry of Defence of the Republic of Estonia, the Ministry of Defence of the Republic of Finland, The Minister for the Armed Forces of the French Republic, the Federal Ministry of Defence of the Federal Republic of Germany the Minister of Defence of the Italian Republic, the Ministry of Defence of the Republic of Latvia, the Ministry of National Defence of the Republic of Lithuania, the Ministry of Defence of Montenegro, the Minister of Defence of the Kingdom of the Netherlands, the Ministry of Defence of the Kingdom of Norway, the Minister of National Defence of the Republic of Poland, the Ministry of Defence of Portugal, the Ministry of Defence of the Slovak Republic, the Ministry of Defence of the Republic of Slovenia, the Minister of Defence of the Kingdom of Spain and the Ministry of Defence of the former Yugoslav Republic of Macedonia<sup>1</sup> concerning multinational cooperation for the provision of Land Battle Decisive Munitions entered into effect on 12 July 2018 (hereinafter referred to the “LBDM MoU”);

Considering Amendment n°1 to the LBDM MOU among the Federal Minister of Defence of the Republic of Austria, the Minister of Defence of the Kingdom of Belgium, the Ministry of Defence of the Republic of Croatia, the Ministry of Defence of Denmark, the Ministry of Defence of the Republic of Estonia, the Ministry of Defence of the Republic of Finland, The Minister for the Armed Forces of the French Republic, the Federal Ministry of Defence of the Federal Republic of Germany, the Ministry of Defence of the Italian Republic, the Ministry of Defence of the Republic of Latvia, the Ministry of National Defence of the Republic of Lithuania, the Ministry of

Defence of Montenegro, the Minister of Defence of the Kingdom of the Netherlands, the Ministry of Defence of the Republic of North Macedonia, the Ministry of Defence of the Kingdom of Norway, the Minister of National Defence of the Republic of Poland,

## **SECTION 1: PURPOSE**

The purpose of this amendment is to enact the participation of the Ministry of Defence of the Czech Republic and the Government of the Kingdom of Sweden to the LBDM MoU.

3.3 This Amendment N°2 to the LBDM MoU is signed in the English and French language, each text being equally valid. The originals of this Amendment N°2 will be kept with the Belgian Participant, which will transmit certified copies to each of the Participants.
