

Pursuant to Article 44 paragraph 1 of the Law on Public Enforcement Officers (Official Gazette of Montenegro, 61/11), in its meeting of January, 30th 2014, the Government of Montenegro adopted the following:

DECREE ON THE AMENDMENTS TO THE DECREE ON THE TARIFF OF PUBLIC ENFORCEMENT OFFICERS

Article 1

In the Decree on the Tariff of Public Enforcement Officers (Official Gazette of Montenegro, 28/13) Article 2 shall be replaced by the following text:

"Remuneration for the work of public enforcement officer shall be composed of the remuneration for preparing the cases, remuneration for undertaken actions and remuneration for successful enforcement.

Preparing the case shall include the process of establishing whether the proposal for enforcement is proper, calculating interest, calculating advance amount of the costs and other actions that precede the adoption of the writ of enforcement.

The amounts of remunerations referred to in paragraph 1 hereof shall include VAT."

Article 2

In paragraphs 1 and 2 of Article 3 the words "and conducting" shall be deleted.

Article 3

In Article 4 paragraph 3 shall be amended to read:

"In case of partial enforcement, remuneration for successful enforcement shall be established and collected in the percentage in which the enforcement was successful."

Article 4
