ECO VIGNETTE, OBTAINED AGAINST THE PAYMENT OF ECO-FEE, REMAINS VALID FOR ONE YEAR.

Foreign legal and natural persons using motor vehicles for the transport of cargo, with maximum allowed mass exceeding 3.5 t, but below 12 t (N2 category) and those using motor vehicles for the transport of cargo, with maximum allowed mass exceeding 12 t (N3 category), depending on how long they stay in Montenegro, pay a daily, weekly, monthly or annual eco-fee.

- 💡 *One-day vignette is valid for the period covering the day when it was bought (issued) and lasts until the end of the next day.*
- 💡 *Weekly vignette is valid for seven days from the date of issuance.*
- 💡 *Monthly vignette is valid for one month from the date of issuance.*
- 💡 *Annual vignette is valid for one year from the date of issuance.*

What is an eco-fee and who is it charged against?

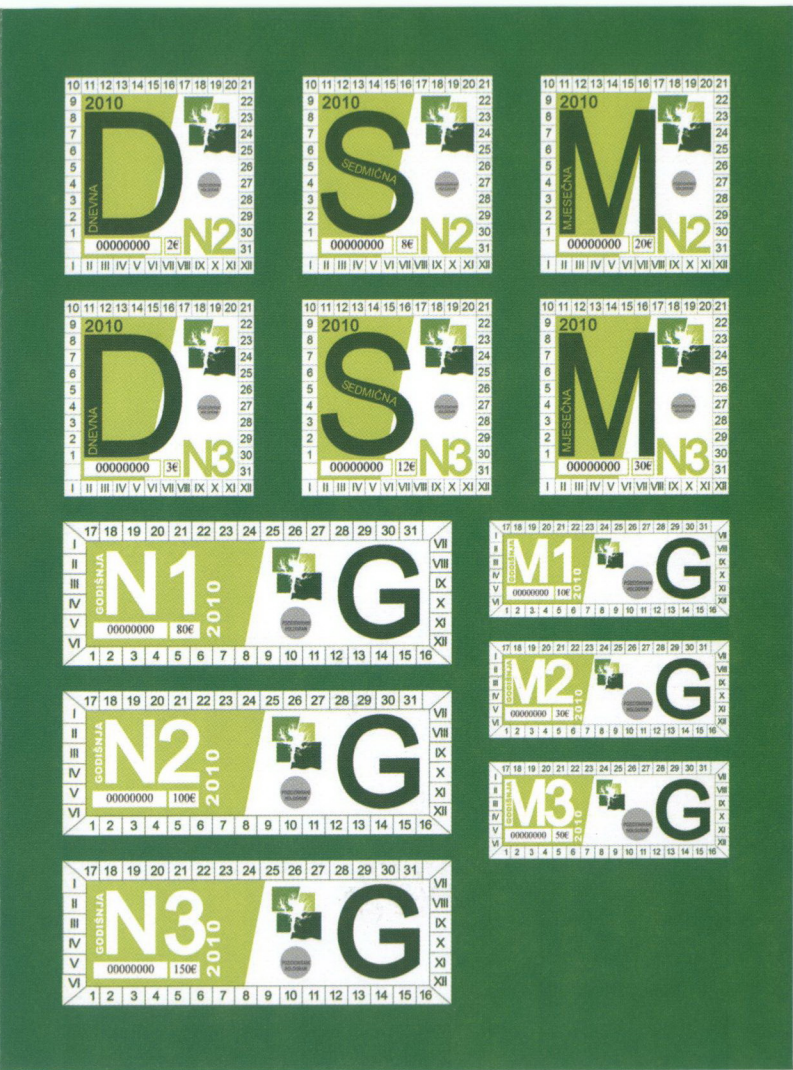
Eco-fee is paid by all domestic and foreign legal and natural persons who use motor vehicles and trailers in land transport in the territory of Montenegro. Montenegrin citizens are charged the eco-fee when they register their cars, while foreign citizens pay this fee at border crossing, when entering Montenegro. The amount of the fee depends on the type of vehicle and trailers used.

The sticker is to be affixed on the internal side of front windshield glass, in the upper right corner.



PENALTY PROVISIONS

- A fine ranging from 10-fold to 200-fold minimum official monthly salary in Montenegro shall be imposed for an offense against a legal person which fails to pay eco-fee while using motor vehicles and appropriate trailers, and which fails to use the vignette in the manner prescribed by the Decree on the amount, manner of calculation and payment of fees. The responsible person in the same legal person shall be also fined an amount ranging from 3-fold to 10-fold minimum official monthly salary in Montenegro.
- A fine ranging from 3-fold to 10-fold amount of minimum official monthly salary in Montenegro shall be imposed for an offense against natural person who is driving a motor vehicle, as well as the natural person running the motor vehicle, on the spot, by a fine up to 3-fold amount of minimum official monthly salary in Montenegro.
