Pursuant to Sub-clause 4.4 of the Design and Build Contract for the Bar-Boljare Highway, priority section Smokovac-Uvac-Matasevo, No. 01-827/1 dated 26 February 2014. ("Official Gazette of Montenegro" No. 54/14), the Ministry of Transport and Maritime Affairs, as the Employer, hereby issues the following:

#### PRIOR APPROVAL No. 74 For Subcontracting

At the request of Contractor, No. RB-BBH/3314/CD dated 11 September 2017, prior approval is hereby granted for the subcontractor **YU BRIV doo Kotor** to pile foundation works of Bridge TARA1, Ramp Bridge 1 (26#) and Ramp Bridge 2 (27#).

Within 7 (seven) days prior to the commencement of the Subcontractor's engagement, the Contractor shall submit to the Engineer the relevant document on the subject, value and duration of the subcontracting contract. This document shall be signed and verified both by the Contractor and Sub-Contractor. If the foregoing is not complied with, this Approval shall cease to apply.
