The Montenegro has received financing from the World Bank toward the cost of Climate Resilient Fisheries and Agrifood Sector Development Project (CRFASD), and intends to apply part of the proceeds toward payments under the contract for Construction of House of Agriculture Berane (regional office of Directorate for IPARD payment, Advisory service of MAFWM and AFSVFA offices in Berane).

The Ministry of Agriculture, Forestry and Water Management, through Technical Service Unit (TSU), now invites sealed bids from eligible bidders for Procurement of Construction of Agency for Payment Regional office in Nikšić (House of Agriculture), consisting of: Construction works, Water system and canalization, Electrical installation high voltage, Electrical installation low voltage, Thermotechnical installation.

Bidding will be conducted through National competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement in Investment Project Financing Goods, Non-Consulting and Consulting Services, February 2025 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
