Along with a duplicate of your offer in the Montenegrin language, you should submit adequate technical documentation and catalog(s) and other printed materials or relevant information (in the Montenegrin language) for each offered item, including the names and addresses of companies that provide service in Montenegro Gori (name of the country).

4. Each bidder may submit only one bid. Bids must be submitted by existing companies that do not have ownership, family or partnership ties with the user. Bidders must also submit proof of registration for the activity for which they are issuing a bid.

Bidders are responsible for the reality and reasonableness of the amounts and truthfulness of the information provided in the bids.

5. Belarus, Egypt, Georgia, Israel, Jordan , Lebanon, Libya, Moldova, Morocco, the Palestinian Authority of the West Bank of Gaza, Syria, Tunisia and Ukraine and/or from the countries of the European Economic Area: Norway, Liechtenstein and Iceland.

6. The deadline for the user to deliver your offer to the address indicated in paragraph 2 is: **March 2, 2023.** (must be given at least 15 days from the date of publication of the invitation).

7. You should submit the offer/s in accordance with the following instructions:

- i) **PRICES:** Prices should be indicated for delivery **CIP Kolašin** (place of destination/delivery) for imported goods, i.e. EXW for domestic delivered goods, increased by the cost of delivery to the place of delivery, in accordance with INCOTERMS 2010. Prices should be expressed in euros ( EUR).
- ii) **EVALUATION OF BIDS:** Bids that are determined to be substantially in line with the technical specifications will be evaluated by comparing their prices.

When evaluating the offers, the Buyer will determine for each proposal an estimated price that changes the price from the offer by correcting any of the following arithmetic errors:

- a) in cases where there is a discrepancy between figures expressed in numbers and letters, the amount expressed in letters will be taken into account
- b) in cases where there is a discrepancy between the price per piece and the total amount of that order resulting from multiplying the price per piece by the quantity, the specified price per piece will be taken into account;
- c) if the Supplier does not accept such a correction, its offer will be rejected.

iii) AWARD OF THE ORDER: The order will be awarded to the bidder who meets the required standards of technical and financial ability. The selected bidder will sign the Agreement with the Buyer. The Agreement must be signed by both parties and stamped and must contain provisions for:

- date of signing,
- accurate information about the name of the buyer and supplier,
- the name of the investment,
- the total price of the investment expressed in numbers and words, without VAT
- deadline for completion and/or delivery of the investment,
- warranty term and conditions.

iv) VALIDITY OF OFFER: Your offer(s) must be valid for at least forty-five (45) days from the date marked as the deadline for receipt of offers.
