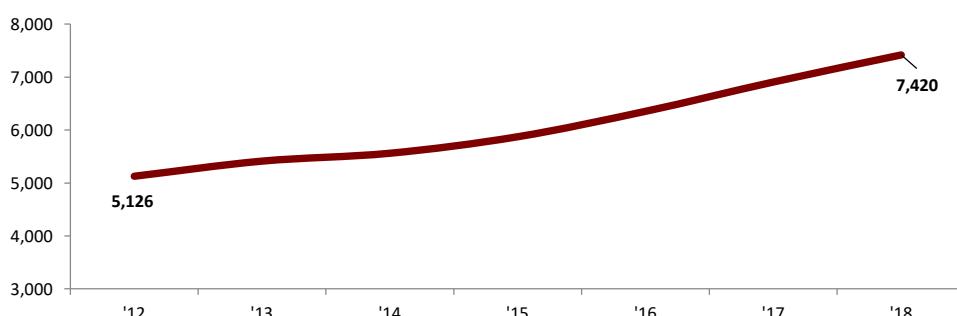

Graph 2 Overnight stays, in mill.

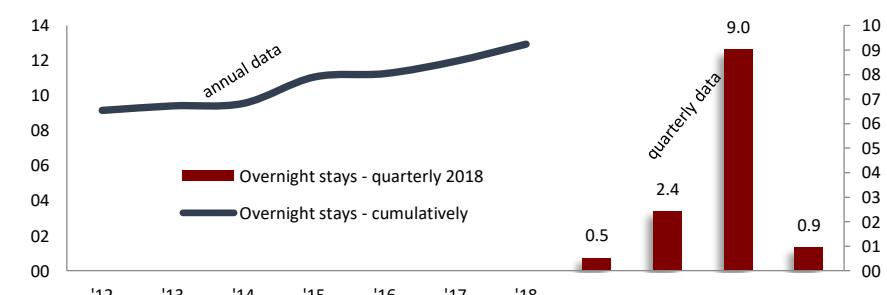
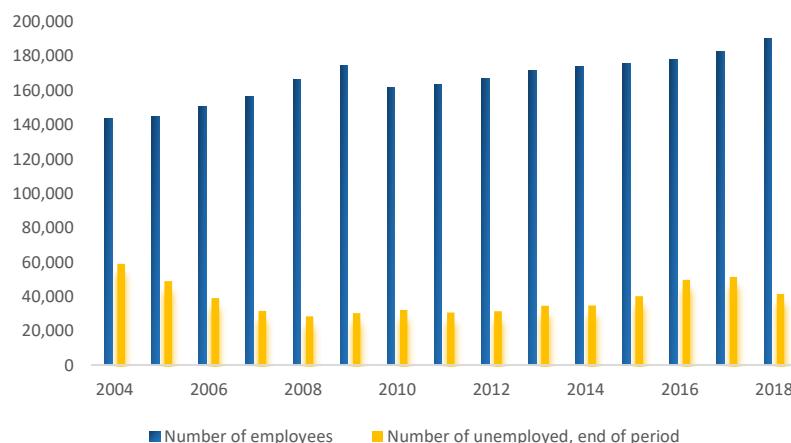

Graph 4 Wages and pension, €

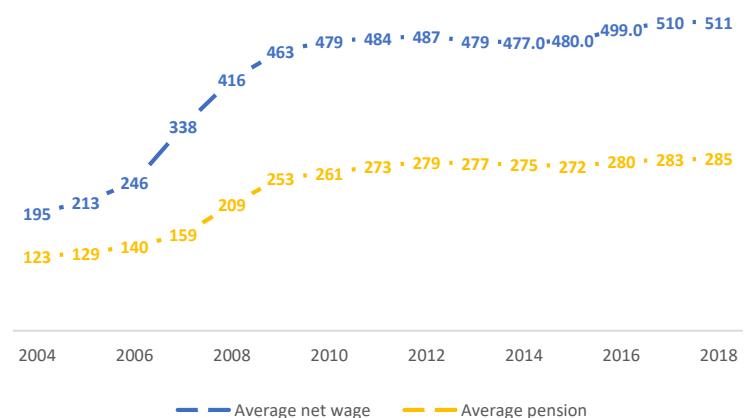
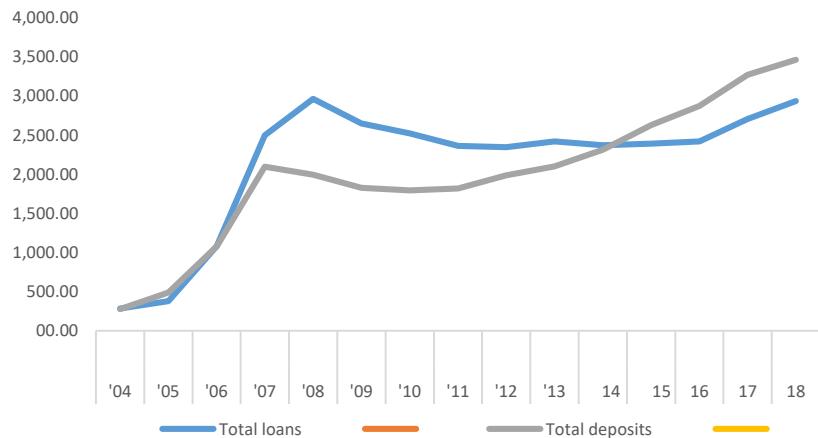

Graph 6 Interest rates, in %

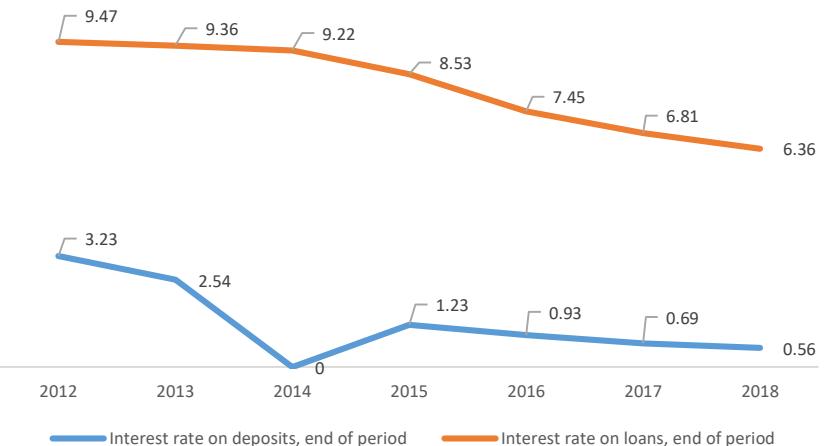
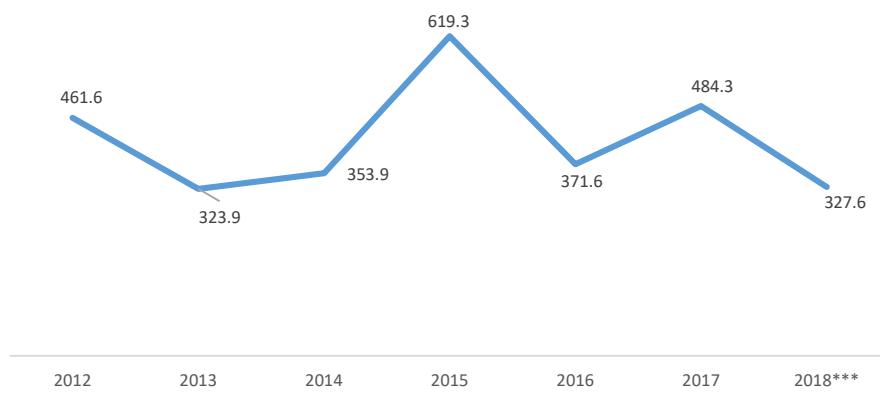

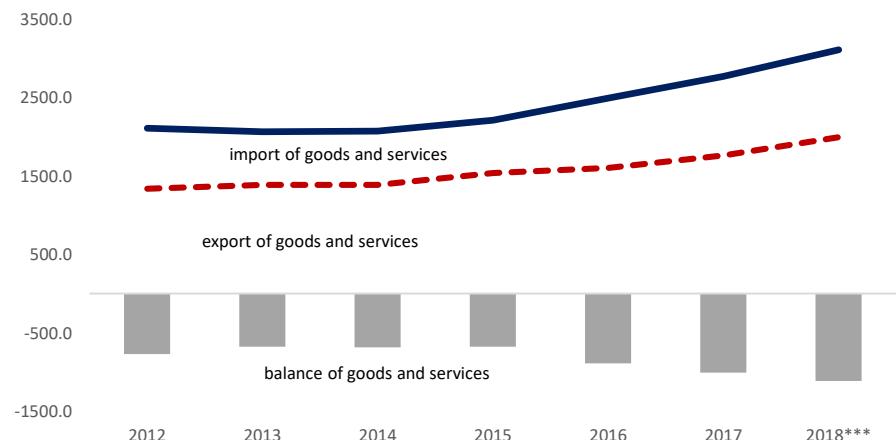

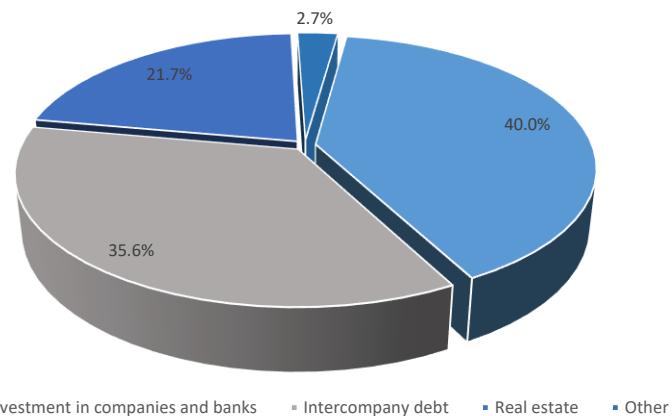
Graph 7 Net FDI, in mill.€

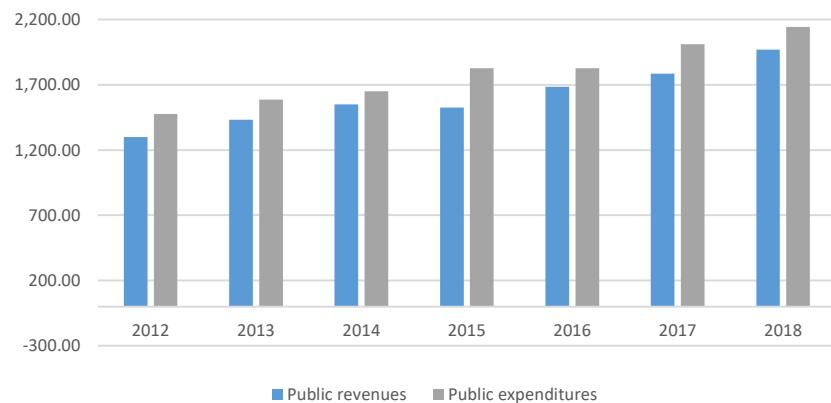

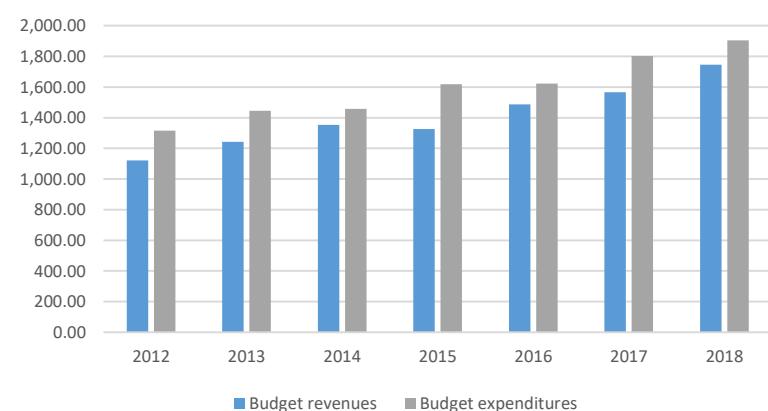

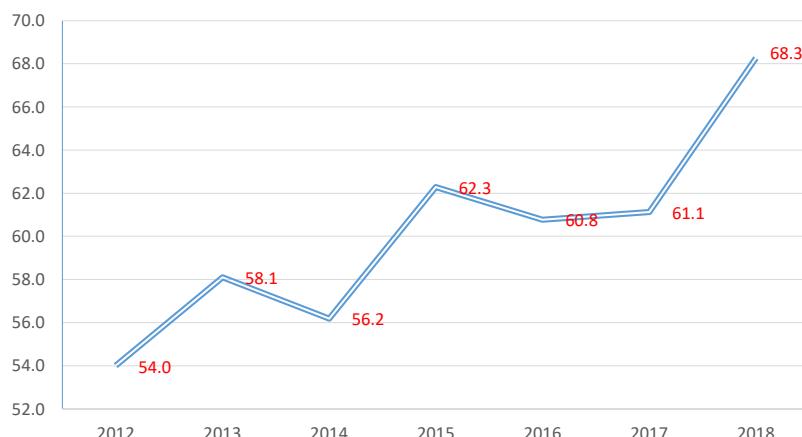
Graph 11 Public revenues and expenditures, in mill.€

Graph 14 State debt, in mill.€

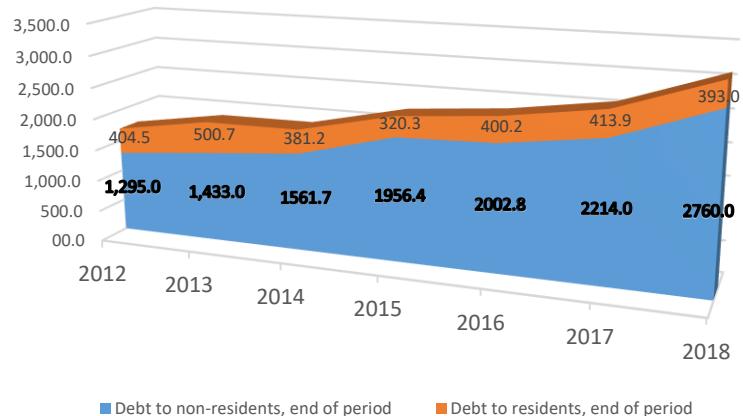
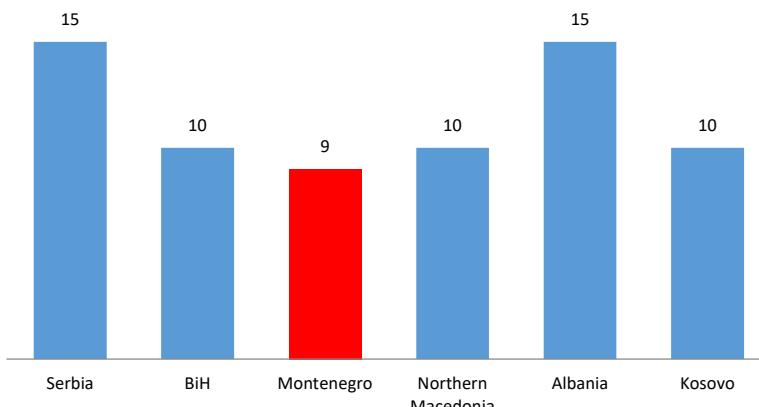

Graph 16 GDP per capita, PPP, international dollars

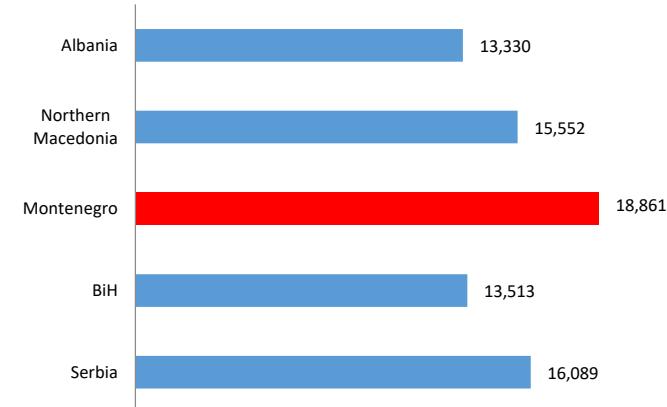
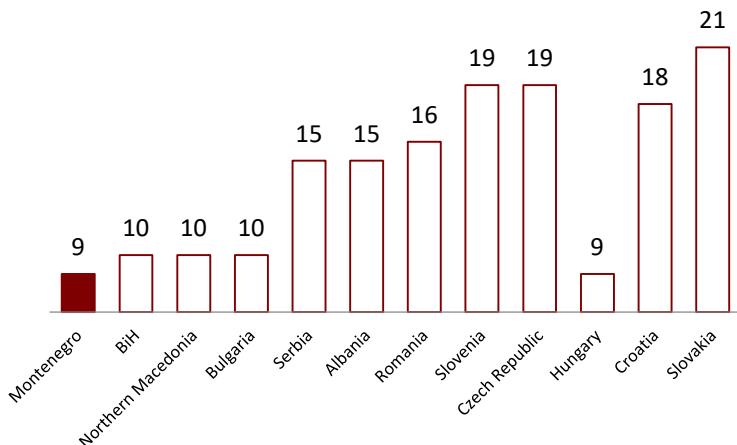
