SESSION I - European funding schemes for research and innovation

Speaker: Antonio Carbone - APRE (Italy), National Contact Point Horizon 2020, "SMEs and Access to risk finance" expert to the European Commission. He is also coordinator of Access4SMEs - European Network of National Contact Point for Innovation of the European Commission. He is advisor for SMEs and Start Ups to enhance innovation management capacities to assess innovation needs.

Horizon 2020, H2020 is a series of operational tools to help you to achieve in excellent science, industrial leadership and tackling societal challenges The main objective of H2020 projects is to develop and co-create an innovative product (or service, process, business model) that ensures a high growth potential of the applicants. This session aims to:

- clarify the basic elements to make a Horizon 2020 proposal convincing in its aspects linked to market sustainability;
- present the main innovations that will characterize the EIC Accelerator (formerly SME Instrument) in 2019-2020;
- to provide a series of operational tools for the applicants, in particular SMEs, innovative spin-offs and start-ups, to adequately consider the size of the market and the business in their loan applications.
