6. Description of the contract

Lot#1: The contract will include design, construction commissioning and operation of the complete and fully functional WWTP Berane. Design shall be prepared for final capacity of the plant of 27,000 PE, while construction works will include only the Phase I of the WWTP of 20,000 PE.

The contract will be implemented as per FIDIC Conditions of Contract for Plant and Design-Build Contract (Yellow Book), First Edition, 1999.

Lot#2: The Works Contract includes construction of wastewater collection system including 21 km sewer mains of various diameters, sewer manholes, River crossing with regulation of River bed along the crossings and 1.4 km of storm-water collectors.

Rehabilitation measures include: replacement of hydraulically undersized main collectors with bigger diameters, separation of combined sewer network and reconnection.

The contract will be implemented as per FIDIC Conditions of Contract for Construction for Building and Engineering Works Designed by the Employer, (Red Book), First Edition 1999

Lot 2: Rehabilitation and Construction of Sewerage Network in Berane (FIDIC Red Book)
