SUBJECT: Prior Consent for Subcontracting (Sub-Clause 4.4 of the Contract)

Pursuant to Sub-Clause 4.4 of the Design and Build Contract for the Bar-Boljare highway, priority section Smokovac-Uvač-Matsevo, no. 01-827/1 dated 26 April 2014 ("Official Gazette of Montenegro" 54/14), the Ministry of Transport and Maritime Affairs, as the Employer, hereby grants the following:

PRELIMINARY CONSENT No. 100

For Subcontracting

At the request of the Contractor no. RB-BBH/1979/CD-P4 dated 3 June 2019, preliminary consent is hereby granted for subcontracting the consortium of **REGENERACIJA d.o.o. Velika Kladusa, Bosnia and Herzegovina, and REGENERACIJA d.o.o. Velika Kladusa, a part of the foreign company seated in Budva**, as a potential subcontractor for the execution of drainage works on the bridges of Uvac 1, Uvac 2, Uvac 3, Uvac 4, Pajkov Vir, Preslo, Jabuka, Tara 1, Tara 2, Matsevo 1 and Matsevo 2 on the section 4.

Bearing in mind the fact that the company **REGENERACIJA d.o.o. Velika Kladusa, Bosnia and Herzegovina** is headquartered outside of Montenegro, the engagement of this company will not be included in the contracted specified scope of subcontracting for the design and execution of works, which shall not be less than 30% of the Accepted Contract amount. All reference documents of the subcontractor, such as licenses, diplomas, certificates, permits, attestations, etc., shall be certificated by the authorized organization of the State of Montenegro.

The Contractor shall submit to the Engineer a relevant document on the subject, value and duration of the subcontracting contract within 7 (seven) days prior to the commencement of the Sub-Contractor's engagement. This document must be signed and stamped by the Contractor and the Sub-Contractor. As a result of failure to act in this way, this Consent shall cease to apply.

Documentation on the Subcontractor's registration, suitability and experience shall constitute the basis and an integral part of the Preliminary Consent.

Izvođač radova je obavezan da u roku od 7 (sedam) dana prije početka rada Podizvođača dostavi Inženjeru odgovarajući dokument o predmetu, vrijednosti i trajanju podizvođačkog ugovora. Ovaj dokument mora biti potpisan i ovjeren od strane Izvođača i Podizvođača. Ukoliko se ne postupi na ovaj način, ova Saglasnost prestaje da važi.
