Pursuant to Article 44 paragraph 1 of the Law on Public Enforcement Officers (Official Gazette of Montenegro 61/11), in its meeting held on 26 April 2013, the Government of Montenegro adopted the following

Decree on the Tariff of Public Enforcement Officers

The Decree was published in the Official Gazette 28/2013 of 14 June 2013 and it came into force on 22 June 2013

Article 1

Public enforcement officer shall be entitled to remuneration for his work and to reimbursement of the costs according to the tariff established in this Decree.

Article 2

Remuneration for the work of public enforcement officer shall be composed of the remuneration for preparing and conducting the cases, remuneration for undertaken actions and remuneration for successful enforcement.

Article 3

The amount of the remuneration for preparing and conducting the cases and for successful enforcement shall be determined in relation to the amount of the mainclaim, i.e. in relation to the value of what is at stake in the dispute related to non-monetary claim established in the enforceable title.

If the value of what is at stake in the dispute related to non-monetary claim is not established in the enforceable title, the amount of the remuneration for preparing and conducting the case shall amount to 35 euro, while the remuneration for successful enforcement shall amount to 300 euro.

Article 4

The amount of the remuneration for successful enforcement shall not exceed 7,500 euro.

Where enforcement is carried out in order to collect monetary claim from the account of the judgment debtor or from the account of a debtor of a judgment debtor, the amount of the remuneration for successful enforcement shall not exceed 3,500 euro.

In case of partial enforcement, remuneration for successful enforcement shall be established in relation to the value of the entire claim, but is collected in the percentage in which the enforcement was successful.

Article 5

Remuneration for successful enforcement shall be reduced:

- by 50% if the obligation was met voluntarily immediately after writ of enforcement is serviced, and before undertaking of the first enforcement action;
- by 25% if the enforcement is carried out through a transfer of funds from the account of the judgment debtor or from the account of a debtor of the judgment debtor, if the enforcement was not attempted in any other way before that.

Article 6

Remuneration for undertaken actions shall be established in relation to the type of the undertaken action and its duration (Table 2), whereby the public enforcement officer shall undertake the actions in themost cost-effective way for the parties.

Article 7

If the judgment debtor settles the claim referred to in the enforceable title after the proposal for enforcement is submitted, and before writ of enforcement is serviced, or if he/she settles the claim within the term envisaged for voluntary enforcement from Article 22 paragraph 2 and Article 41 paragraph 3 of the Law on Enforcement and Security, public enforcement officer shall collect the remuneration for preparing and conducting the enforcement procedure and remuneration for undertaken actions from the judgment debtor.

Article 8

If several judgment creditors or several judgment debtors participate in the process of carrying out the enforcement, public enforcement officer shall be entitled to a remuneration increased by 10% for every party after the first one, up to the amount which is by 50% higher than the full remuneration for one party.

Article 9

Public enforcement officer shall not be entitled to remuneration for the undertaken enforcement action that is subject of the application for elimination of irregularities, and that is repealed by a final decision of the court.

Article 10

Reimbursement of the costs of public enforcement officer shall include: the reimbursement of court and administrative fees; reimbursement of the costs of expertize and assessment; reimbursement of the expenses for storing things; reimbursement of travel expenses and of other costs actually incurred in relation to the implementation of the law.

Article 11

Public enforcement officer shall be entitled to reimbursement of travel costs for the work that is not done in the registered office:

- for long distances in the amount of the costs of public transport;
- in the city and adjacent areas in the amount of the costs of transport by taxi;
- -for the use of his/her own car, in the amount of 15% of the price of one litre of the highest quality gasoline for every kilometre of the travel.

If public enforcement officer undertakes enforcement actions outside of his/her registered office and has to spend nights in a hotel, he/she shall be entitled to reimbursement of the costs of hotel accommodation, except for accommodation in five star hotels.

Article 12

Tables 1 and 2 make a constituent part of this Decree.

Article 13

This Decree shall enter into force on the eight day following that of its publication in the Official Gazette of Montenegro.
