This information pertains to one of the JICA Knowledge Co-Creation Programs (Group & Region Focus) of the Japan International Cooperation Agency (JICA) implemented as part of the Official Development Assistance of the Government of Japan based on bilateral agreement between both Governments.

JICA Knowledge Co-Creation Program (KCCP)

The Japanese Cabinet released the Development Cooperation Charter in June 2023, which stated, "In its development cooperation, Japan has maintained the spirit of jointly creating things that suit partner countries while respecting ownership, intentions and intrinsic characteristics of the country concerned based on a field-oriented approach through dialogue and collaboration. It has also maintained the approach of building reciprocal relationships with developing countries in which both sides learn from each other and grow and develop together." JICA believes that this 'Knowledge Co-Creation Program' will serve as a foundation of mutual learning process.

I. Concept

Background

With the progress in Information and Communications Technology (ICT), the threat of cybercrime which abuses ICT is rapidly increasing. Since cybercrime can easily cross-national boundaries, it is becoming a global concern.

To cope with this situation, it is important for law enforcement organizations in each country to improve the ability of taking measures against cybercrime and to cooperate with foreign organizations.

For what?

This program is aimed at learning Japanese knowledge and experiences of legal system, investigation method/ skill and cooperation with private sector to tackle cybercrime. The program is also intended to build a cooperative network among national police of participating countries and Japan.

For whom?

This program is designed for officers, especially senior officers, of national police who are dealing with cybercrime.

How?

Participants are expected to learn knowledge and experiences of Japanese police related to cybercrime, such as legal system, investigation method, digital forensics, and cooperation with private sector through various lectures and field visits.

They will also analyze the situation on cybercrime in other countries by attending Country Report presentation and Action Plan presentation. Thus, participants will build an international network among them which must be beneficial for future countermeasures against cybercrime in each country.

III. Eligibility and Procedures

1. Expectations to the Applying Organizations

- (1) This project is designed primarily for organizations that intend to address specific issues or problems identified in their operations. Applying organizations are expected to use the program for those specific purposes.
- (2) In this connection, applying organizations are expected to nominate the most qualified candidates to address the said issues or problems, carefully referring to the qualifications described in section III-2 below.
- (3) Applying organizations are also expected to be prepared to make use of knowledge acquired by the nominees for the said purpose.

2. Nominee Qualifications

Applying organizations are expected to select nominees who meet the following qualifications.

[Remarks] Each Organizations is requested to strongly encourage female candidates to apply for the course to accelerate the realization of gender equality and women's empowerment.

Disabilities: Persons with disabilities who meet the required qualifications also have an opportunity to apply. Reasonable accommodations will be considered for participants with disabilities. Some programs of the course might have difficulty for persons with disabilities to participate due to environmental and other conditions. "Reasonable accommodation" means necessary and appropriate modification and adjustments not imposing a disproportionate or undue burden, where needed in a particular case.

(1) Essential Qualifications

- 1) Current Duties: Be director, assistant director or equivalent in principle, of cybercrime related divisions in national police and be currently engaged in investigation, countermeasures, or digital forensics.
- **2) Experience in the relevant field:** Have more than one year experience in the field of cybercrime.
- 3) Nomination: Be nominated by their government in accordance with the procedure mentioned in III-3 below, Not have participated in the same kind of course hosted by either National Police Agency of Japan or JICA in the past.
- **4)** Language Proficiency: In principle, applicants need to have sufficient English language skills (This program includes active participation in discussions and presentation, thus requires English ability.)
 - *Please attach an official certificate for English ability such as IELTS, TOEFL, TOEIC, if possible.
- **5) Health:** Must be in good health to participate in the program in Japan. To reduce the risk of worsening symptoms associated with respiratory tract

infection, please be honest to declare in the Medical History (QUESTIONNAIRE ON MEDICAL STATUS RESTRICTION of the application form) if you have been a patient of following illnesses; Hypertension / Diabetes / Cardiovascular illness / Heart failure / Chronic respiratory illness.

(2) Recommended Qualifications

- 1) Age: Favorably in the 30s or 40s, in principle
- 2) Gender Equality and Women's Empowerment: JICA seeks more female applicants due to the past records of fewer applications from women. JICA is committed to promoting gender equality and women's empowerment and provides equal opportunities for all applicants regardless of their sexual orientation or gender identity.

3. Required Documents for Application

- (1) Application Form: The Application Form is available at the JICA overseas office (or the Embassy of Japan)
 - * If you have any difficulties/disabilities which require assistance, please specify necessary assistances in the QUESTIONNAIRE ON MEDICAL STATUS RESTRICTION (1-(c)) of the application form. Information will be reviewed and used for reasonable accommodation.
- (2) Photocopy of Passport: You should submit it with the application form if you possess your passport which you will carry when entering Japan for this program. If not, you are requested to submit its photocopy as soon as you obtain it.
 - *The following information should be included in the photocopy: Name, Date of Birth, Nationality, Sex, Passport Number and Expiry Date
 - *It is recommended that your passport be valid for more than 6 months after the last day of the program.
- (3) ANNEX: Attach ANNEX which specifies your police rank (if not, military rank) and position (including bureau, department, and section in your organization). Both should be typewritten, and the latter should be attached to the former on application. Please be noted that this ANNEX is subject to consideration for the selection of participants. (Note: Applicant's position / responsibility must be clearly described for selection purposes.)
- **(4) Organization Chart**: The applicant must submit <u>an Organization Chart</u> of their respective organization together with the Application Form.
 - Please clearly indicate the applicant's position on the chart. Submission of Organization Chart is considered as an important information in the selection process of participants.

4. Procedures for Application and Selection:

(1) Submission of the Application Documents:

Closing date for applications: Please confirm the local deadline with the JICA overseas office (or the Embassy of Japan).

(All required material must arrive at JICA Tokyo Center (JICA TOKYO) in Japan by November 27th, 2025

(2) Selection:

Primary screening is conducted at the JICA overseas office (or the embassy of Japan) after receiving official documents from your government. JICA Center will consult with concerned organizations in Japan in the process of final selection. Applying organizations with the best intentions to utilize the opportunity will be highly valued.

The Government of Japan will examine applicants who belong to the military or other military-related organizations and/or who are enlisted in the military, taking into consideration of their duties, positions in the organization and other relevant information in a comprehensive manner to be consistent with the Development Cooperation Charter of Japan.

(3) Notice of Acceptance

The JICA overseas office (or the Embassy of Japan) will notify the results **not** later than December 18th, 2025.

5. Additional Document(s) to Be Submitted by Accepted Candidates:

Country Report -- to be submitted by January 15, 2026

Accepted participants are required to prepare "Country Report" based on latest information on the police organization, its systems and especially the problems/ challenges which the police of participating countries confront. A format for "Country Report" and an instruction about the report formulation will be sent to the accepted candidates at the same time with the acceptance letter.

6. Conditions for Participation

The participants of KCCP are required:

- (1) to strictly observe the course schedule,
- (2) not to change the air ticket (and flight class and flight schedule arranged by JICA) and lodging by the participants themselves,
- (3) to understand that leaving Japan during the course period (to return to home country, etc.) is not allowed (except for programs longer than one year),
- (4) not to bring or invite any family members (except for programs longer than one vear).
- (5) to carry out such instructions and abide by such conditions as may be stipulated by both the nominating Government and the Japanese Government in respect of the course.

- **(6)** to observe the rules and regulations of the program implementing partners to provide the program or establishments,
- (7) not to engage in political activities, or any form of employment for profit,
- (8) to discontinue the program, should the participants violate the Japanese laws or JICA's regulations, or the participants commit illegal or immoral conduct, or get critical illness or serious injury and be considered unable to continue the course. The participants shall be responsible for paying any cost for treatment of the said health conditions except for the medical care stipulated in (3) of "5. Expenses", "IV. Administrative Arrangements",
- (9) to return the total amount or a part of the expenditure for the KCCP depending on the severity of such violation, should the participants violate the laws and ordinances.
- (10) not to drive a car or motorbike, regardless of an international driving license possessed,
- (11) to observe the rules and regulations at the place of the participants' accommodation, and
- (12) to refund allowances or other benefits paid by JICA in the case of a change in schedule.

For Your Reference

JICA and Capacity Development

Technical cooperation is people-to-people cooperation that supports partner countries in enhancing their comprehensive capacities to address development challenges by their own efforts. Instead of applying Japanese technology per se to partner countries, JICA's technical cooperation provides solutions that best fit their needs by working with people living there. In the process, consideration is given to factors such as their regional characteristics, historical background, and languages. JICA does not limit its technical cooperation to human resources development; it offers multi-tiered assistance that also involves organizational strengthening, policy formulation, and institution building.

Implementation methods of JICA's technical cooperation can be divided into two approaches. One is overseas cooperation by dispatching experts and volunteers in various development sectors to partner countries; the other is domestic cooperation by inviting participants from developing countries to Japan. The latter method is the Knowledge Co-Creation Program, formerly called Training Program, and it is one of the core programs carried out in Japan. By inviting officials from partner countries and with cooperation from domestic partners, the Knowledge Co-Creation Program provides technical knowledge and practical solutions for development issues in participating countries.

The Knowledge Co-Creation Program (Group & Region Focus) has long occupied an important place in JICA operations. About 400 pre-organized course cover a wide range of professional fields, ranging from education, health, infrastructure, energy, trade and finance, to agriculture, rural development, gender mainstreaming, and environmental protection. A variety of programs is being customized by the different target organizations to address the specific needs, such as policy-making organizations, service provision organizations, as well as research and academic institutions. Some programs are organized to target a certain group of countries with similar developmental challenges.

Japanese Development Experience

Japan, as the first non-Western nation to become a developed country, built itself into a country that is free, peaceful, prosperous and democratic while preserving its tradition. Japan will serve as one of the best examples for our partner countries to follow in their own development.

From engineering technology to production management methods, most of the know-how that has enabled Japan to become what it is today has emanated from a process of adoption and adaptation, of course, has been accompanied by countless failures and errors behind the success stories.

Through Japan's progressive adaptation and application of systems, methods and technologies from the West in a way that is suited to its own circumstances, Japan has

developed a storehouse of knowledge not found elsewhere from unique systems of organization, administration and personnel management to such social systems as the livelihood improvement approach and governmental organization. It is not easy to apply such experiences to other countries where the circumstances differ, but the experiences can provide ideas and clues useful when devising measures to solve problems.

JICA, therefore, would like to invite as many leaders of partner countries as possible to come and visit us, to mingle with the Japanese people, and witness the advantages as well as the disadvantages of Japanese systems, so that integration of their findings might help them reach their developmental objectives.

National Police Agency (NPA) of Japan



Police responsibilities under the Police Act include "protecting life, person, and property; preventing, suppressing, and investigating crimes; apprehending suspects; traffic enforcement; and, maintaining public safety and order." The Code of Criminal Procedure states that "when a judicial police official deems an offense has been committed, he shall investigate the offender and evidence thereof." Accordingly, the police are empowered to investigate not only penal code offenses but also all illegal acts punishable under Japan's judicial system. Most cases are investigated by the police and referred to the public prosecutor's office for prosecution. While public prosecutors are also empowered to conduct investigations, their investigations are generally supplementary. The primary duty of the public prosecutor is to determine case dispositions and prosecute suspects.

In addition to criminal investigations, the police perform a wide range of administrative activities to maintain public safety and order applying various acts such as the Road Traffic Act and the Anti-Boryokudan Act.

The police also maintain close contact with local communities to: prevent crimes; handle lost and found articles; give guidance to juveniles; help people in times of disaster; provide care for lost children and runaways; and, offer counseling services to help citizens solve their problems.

The National Police Agency was established in 1954 and the present police system was formed. The NPA, as a national agency, formulates police systems and also conducts police operations regarding cases involving national public safety, undertakes the administration of matters which form the foundation of police activities such as police education and training, police communications, criminal identification as well as the development of police administration.
