# DP-DTEA-00-04 - INVITATION FOR THE OFFERS/QUOTATIONS FOR GOODS

Project Title - Name of the investment: Procurement of equipment, machines and devices for cleaning and washing objects and tools, equipment for processing by-products of plant origin and other equipment necessary in the mushroom processing plant.

Dear Supplier(s),

- 1. You are invited to submit your offer/quotation(s) with exact prices and quantities for the supply of the following items:
  - (i) Line for preparation and filling of peat into nylon bags.
- (v) Information on technical specification (minimal technical specification) for each item, which is contracted (horse power, operational width, engine speed, bearing capacity, etc.)

The line contains the following elements:

1. Receiving basket with dimensions of 2000 x 1000 x 1000mm into which peat is poured with your loading machine.

The receiving bin from where the peat goes to the mill on a conveyor belt has a volume of 2 m3. It is located above the conveyor belt.

2. The conveyor belt that takes the peat from the basket to the mill is rubber and is mounted on a metal structure, 500 mm wide and 4 m long. Motor 0.75kw/380v. The operation of the belt is regulated automatically and it only works when there is no peat in the charger basket.

- 3. Mill for grinding peat. The mill grinds peat, has its own smaller basket and it works constantly so that small switching on or off does not lead to suffocation. The mill grinds peat with chains. Motor 5kw/380v. The peat from the mill falls into the basket of the conveyor belt which carries the peat to the basket of the charger.
- 4. The rubber accordion conveyor belt is mounted on a 6m long metal structure and carries the peat from the mill to the charger basket. Motor 0.75kw/380v.
- 5. Automatic filler that makes bags from a roll of foil. The charger is automatic. The size of the bag is determined by the collar, which is an integral part of the charger. The installed power of the charger is 2kw. Basically dimensions 2500 x 2000 x height 3800mm. The charger has computer control.
- 6. Exit lane of full bags. Width 700mm, length 3m, works in sync with the charger Motor 0.50kw/380v.
- 7. The palletizer serves to wrap a full pallet with stretch film. Maximum pallet size EURO pallets. Pallet weight up to 2000kg. The height of the palletizer is 2.5 m. It has tensioning force adjustment, film folding adjustment and rotation speed. Motor 0.75kw/380v. Dimensions: length 3m x circle film 1500mm x height 2.5m.
- 8. Collar for forming bags of 5 and 10 liters of nylon bag volume for peat.
- 9. Collar for forming bags of 20 liters of nylon bag volume for peat.
- 10. Collars for forming bags of 50 liters volum nylon bags for peat.
- 11. Compressor 200 liters.
- 12. Installation, commissioning of equipment and training.
- 13. Electrical installation for a complete drive with a distribution switch, all the necessary elements in it and a supply cable 10x6mm.
- 14. Tractor trailer with a load capacity of 4000 kg, one axle, three side extensions, box dimensions 300x200x110 cm, tipping on 3 sides, hydraulic braking system, parking foot

Note that the contracted price with Directorate for payment for listed items is 89.700,00EUR.

- 4. Each bidder must submit only one bid. Bids must be submitted by existing companies which have no proprietary, kinship or partnership with the recipient. The Bidder must also provide proof of registration for the activity for which it is performed

Bidders are responsible for the reality and reasonableness of the amount and truthfulness of the information provided in the offers

- 7. Your quotation(s) should be submitted as per the following instructions:
- (i) <u>PRICES</u>: The prices should be quoted for delivery CIP Spuz bb, Danilovgrad, Montenegro (place of destination) for imported goods or EXW for domestically supplied goods plus the price of delivery to the place of destination, according to INCOTERMS, 2010. Prices should be quoted in Euro.
- (ii) <u>EVALUATION OF QUOTATIONS</u>: Offers determined to he substantially responsive to the minimal technical specifications will be evaluated by comparison of total price.

In evaluating the quotations, the Purchaser will determine for each proposal the evaluated price by adjusting the price quotation by making any correction for any arithmetical errors as follows:

- (a) where there is a discrepancy between amounts in figures and in words, the amount in words will govern;
- (b) where is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern;
  - (c) if a Supplier refuses to accept the correction, his quotation will be rejected.

Also, amounts stated in the offers must will be expressed in EYP, each offer/quotation must clearly indicate if the Value Added Tax (VAT) is included in the price and the amount and percentage of the VAT. The VAT percentage should be indicated for the country of Supplier.

(iii) <u>AWARD OF PURCHASE ORDER</u>: The award will be made to the bidder that meets the required standards of technical and financial capabilities. The successful bidder will sign a Contract with the Purchaser. The Contract has to be signed by both parties and stamped and it should include the stipulations for:
