Na zahtjev Izvođača radova, br. RB-BBH/0361/PC od 14.3.2016. godine daje se prethodna saglasnost (Dopuna br. 1) za angažovanje podizvođača **MONTENEGRO PETROL d.o.o. Podgorica**, za:

1. Održavanje i jačanje Mateševo mostova - most preko rijeke Tare i most preko rijeke Drcke;
2. Pristupni put;
3. Privremeni radovi pored portala tunela br. 16, br. 17 i br.18 koji uključuju zemljani iskop, livenje betona za kolovoz i temelj montažne kuće;
4. Iskop, livenje kontrolne tačke mjerenja, nabavku propusta.

Izvođač radova je obavezan da u roku od 7 (sedam) dana prije početka rada Podizvođača dostavi Inženjeru odgovarajući dokument o predmetu, vrijednosti i trajanju podizvođačkog ugovora. Ovaj dokument mora biti potpisan i ovjeren od strane Izvođača i Podizvođača. Ukoliko se ne postupa na ovaj način, ova Saglasnost prestaje da važi.

SUBJECT: Prior Approval of the Subcontractor (Sub-clause 4.4 of the Contract)

Pursuant to Sub-clause 4.4 of the Design and Build Contract for the Bar-Boljare highway, priority section Smokovac-Uvac-Matesevo, No. 01-827/1 of 26 February 2014 ("Official Gazette of Montenegro" no. 54/14), the Ministry of Transport and Maritime Affairs, as the Employer, hereby issues the following:

PRIOR APPROVAL No. 12 – Amendment No. 1 For Subcontracting

At the request of the Contractor, No. RBBH/0361/PC of 14 March 2016, prior approval is hereby granted (Amendment No. 1) for subcontracting **MONTENEGRO PETROL doo Podgorica**, for:

1. Maintaining and strengthening Matesevo bridges - a bridge over the Tara River and a bridge over the River Drcko;
2. Access road;
3. Temporary works next to the portal of the tunnels no. 16, no. 17 and no.18, which include earth excavation, casting concrete for the roadway and the foundation of a prefabricated house;
4. Excavation, casting, control points of measurement, procurement of culverts.

Within 7 (seven) days before the subcontractor starts working, the Subcontractor shall submit to the Engineer the required document on the subject, value and duration of the subcontracting agreement. This document shall be signed and certified by the Contractor and Subcontractor. In case of failure to act in this way, the approval shall be repealed.

Documentation of registration, eligibility and experience of the Subcontractor shall constitute the basis and an integral part of the prior approval.
