

ANNEX 1: Description of Requirements

Context of the Requirement	<p>The project “Biodiversity mainstreaming into Sectoral Policies and Practices and Strengthening Protection of Biodiversity Hot-spots in Montenegro” is geographically focused on the Key Biodiversity Areas (KBAs) of Montenegro and includes various types of interventions and involves both ecosystem protection and work with production sectors, such as tourism, agriculture and forestry.</p> <p>Within the framework of the project, we provide support to the Regional Development Agency for Bjelasica, Komovi and Prokletije in the process of preparing an international nomination of katuns as cultural heritage under the FAO Globally Important Agricultural Heritage Systems (GIAHS) programme. In parallel, the national nomination process of katuns as cultural heritage is in its final phase, further confirming the cultural, historical, and environmental significance of this traditional system.</p> <p>Recognizing the need to raise awareness and enhance the visibility of katuns at both national and international levels, the project foresees the production of a series of promotional videos during 2026, the Global Year of Katuns. These videos, each 5 to 10 minutes long, will present katuns as living systems, highlighting traditional ways of life, their contribution to biodiversity conservation, the role of women, and the involvement of young people in inheriting and revitalizing these practices.</p> <p>This activity contributes directly to Outcome 5, supporting traditional livelihoods, the revitalization of traditional agriculture (grazing) and nomadic settlements (katuns) as key elements representing the unique cultural value of the area. At the same time, it aims to ensure community engagement and increase local benefits from traditional agriculture and sustainable tourism development, positioning katuns as an authentic heritage-based model that cannot be replicated elsewhere.</p>
Brief Description of the Required Services	<p>The objective of this assignment is to produce five promotional films focusing on the seasonal movement to katuns (izdiga) as a traditional pastoral practice placed under national protection as intangible cultural heritage. The films aim to bring this practice closer to the general public and to present its overall social, cultural, and environmental significance, particularly in light of the fact that 2026 has been proclaimed the International Year of Pastoralism.</p> <p>The project team within the Ministry of Ecology, Sustainable Development and Northern Region Development is inviting proposals from reputable and qualified experts with a track record of success in filming, editing and producing promotional videos.</p>
List and Description of Expected Outputs to be Delivered	<p>Selected vendor for production of 5 promotional videos will have the following specific responsibilities during the period from 10 March 2026 – 31 October 2026 (with possibility of extension):</p> <ol style="list-style-type: none"> 1) The Vendor undertakes to comply with all provisions of this Contract and with applicable national legislation; 2) The Vendor shall be fully responsible for fulfilling all assumed legal obligations; 3) The Vendor shall provide personnel, facilities, equipment, and materials to the extent necessary for the implementation of activities in accordance with the requirements for producing 5 promotional videos; 4) In the process of concept development, selection of interviewees, filming locations, and film editing, the Vendor shall consult representatives of the Regional Development Agency for Bjelasica, Komovi and Prokletije and the project team of the project “Integrating Biodiversity into Sectoral Policies and
