REGIONAL WORKSHOP ON GOVERNMENT PROCUREMENT FOR CENTRAL AND EASTERN EUROPE, CENTRAL ASIA AND THE CAUCASUS COUNTRIES Vienna, Austria

10-12 December 2019

The Secretariat of the World Trade Organization, with the financial assistance of the Global Trust Fund and the co-operation of the Joint Vienna Institute (JVI) and the European Bank for Reconstruction and Development (EBRD), is organizing a Regional Workshop on Government Procurement for Central and Eastern Europe, Central Asia and the Caucasus (CEECAC) countries, to be held in Vienna, Austria, from 10 to 12 December 2019.

The Workshop has as its purpose to provide a forum for trade and procurement experts to exchange information and experiences on policy and related issues in the government procurement sector, and to consider their implications for trade and economic performance.

The theme of this Workshop is: "Government procurement and international trade disciplines: relevant WTO activities, regional developments, and policy considerations for transition and emerging economies."

The main objectives of the programme are: (i) to familiarize participants with WTO and EBRD activities related to government procurement, notably as they relate to trade, governance and economic performance; (ii) to elaborate on the benefits and challenges associated with accession to and implementation of the Agreement on Government Procurement and the procedures and modalities to be followed, in addition to related policy issues; and (iii) to discuss international and regional standards, developments and trends in the area of government procurement. An indicative draft programme of the workshop is attached.

As the Workshop will be held in English, participants will be required to be fluent in English. It is anticipated, however, that interpretation into Russian will be provided courtesy of EBRD.

Your Government is invited to nominate **up to** <u>four capital-based officials</u> to participate in this activity. The officials should have policy responsibility in relation to WTO and/or government procurement matters. They should be chosen from the Trade or Commerce Ministry, and from the national Procurement Authority, Ministry of Finance or other Ministry or Agency with policy responsibility in this area.

A selection committee will consider all applications received and retain an overall maximum of **30 funded places**. Preference will be given to nominees having policy responsibility and/or a demonstrated background in trade and/or government procurement policy matters.

A round trip airplane ticket in economy class, accommodation for the duration of the course, a daily subsistence allowance and a terminal expenses allowance will be provided to funded candidates. Further administrative details will be communicated to selected funded participants directly.

The Application forms, duly signed by the authorities presenting the nominees and validated by the Permanent Mission, should be transmitted to the WTO Institute for Training and Technical Cooperation, Logistics Unit (email: logistics.unit@wto.org or fax +41 22 739 5724) NO LATER THAN 14 OCTOBER 2019.

Please note that the complex preparations and logistical arrangements for this activity mean that the WTO Secretariat cannot consider any applications received after the above date and/or without the validation by the applicants' Permanent Mission/Embassy to the WTO.

The WTO Secretariat reserves the right to postpone or cancel the activity in the event of force majeure or other reasons that render the execution of the activity impracticable for the organizers.

Participants will be required to contribute to the seminar by providing comments on their national experiences, particularly during the breakout sessions and the general discussion sessions for each topic area and should come duly prepared.
