Subject of the Agreement  
Article 1

Subject of this Agreement is software maintenance for Petrel E&P Software Platform (hereinafter referred to as the "Maintenance"), in accordance with the Request for submitting offers by shopping method 01-1062/2 as of 30 April 2015 and Decision on selection of the best Offer No. 01-1062/8 as of 8 June 2015, and in line with the Provider's Offer.

The Maintenance referred to in paragraph 1 of this Article shall include:

- Upgrade to the latest version of Petrel E&P Software Platform

- Tehničku podršku putem email-a i telefona, kao i pristup geo-portalu kroz upite u vezi Petrel E&P Software Platformm
- Godišnje ažuriranje "šta je novo" u naknadnim Petrel E&P Software Platform verzijama.

#### Član 2

#### Član 5

#### Termination of the Agreement

#### Article 6

The Contracting Parties agree that this Agreement may be terminated if the Provider fails to meet his obligations within deadlines and in a way as stipulated by the Agreement, in the following events:

- When the Ordering Party establishes that the quality of the services provided or the manner of provision thereof deviates from the requested quality, that is to say deviates from the quality offered in the Provider's bid.
- If the Provider fails to act according to the request for technical support filed by the Ordering Party.
- If the Provider refuses to update "What's New" in the subsequent Petrel E&P Software Platform versions.

In case there is a cause for termination of the Agreement referred to in paragraph 1 of this Article, the Ordering Party undertakes to invite the Provider in writing and give the Provider the deadline of 5 working days to remove the observed deficiencies.


