



- Develop a network of useful contacts between participants, trainers and experts from the WTO Secretariat.



- Learned how to interpret the statistics contained in the reports and be able to identify the appropriate online application to use based on type of data required.

# SPS course series 1 - Overview of the SPS Agreement and Committee (NEW)

In this course, you will learn about:



- The objectives, history, structure and scope of the SPS Agreement, as well as its relationship with other WTO Agreements (Module 1);
- The basic obligations under the SPS Agreement (Article 2). These disciplines demand that SPS measures be supported by science and applied only to the extent necessary, and prohibit the application of SPS measures in a discriminatory fashion or as disguised restrictions on international trade (Module 2);
- The structure of the entire SPS Agreement (Module 3). This will serve as preparation for Courses 2 and 3, which will delve into the provisions in more depth;
- The activities of the SPS Committee, a WTO body in which Members regularly convene to discuss the practical implementation of the SPS Agreement (Module 4). The SPS Committee will also be discussed in more depth in Course 4.

#### SPS course series 2 - The SPS Agreement and science (NEW)

In this course, you will learn about scientific justification of SPS measures through studying:



- The principle of regulatory harmonization around relevant international standards (Article 3). You will also learn about the work of the three relevant standard-setting organizations Codex, IPPC and OIE, and how it relates to the obligations of the SPS Agreement (Module 1);
- The SPS Agreement's obligations regarding risk assessment (Article 5, paragraphs 1 to 3) (Module 2);
- The SPS Agreement's obligations regarding the level of protection a WTO Member chooses to maintain in its territory (so-called 'appropriate level of protection') (Article 5, paragraphs 4 to and 6) (Module 3); and
- Temporary measures in emergency situations whee there is insufficient scientific evidence to determine whether a product or process is safe (Article 5.7) (Module 4).

# SPS course series 3 - Trade Facilitating Operational Provisions of the SPS Agreement (NEW)

In this course, you will learn about principles and concepts in the SPS Agreement that provide for mechanisms to facilitate safe trade in agricultural and food products:



- The principle of equivalence, which obliges WTO Members to accept each other's different SPS measures when they achieve the same level of protection (Article 4 of the SPS Agreement);
- The principle of regionalization, according to which Members must adapt their measures to the SPS conditions (for example, regional variations in pest prevalence) of the areas of origin and destination of the product (Article 6);
- Transparency-related requirements to guarantee that information about SPS requirements is systematically communicated and exchanged, resulting in increased certainty and better regulation (Article 7 and Annex B); and
- Rules on the application of control, inspection and approval procedures, which require that such procedures are not lengthier nor more burdensome than necessary and that they do not discriminate between trading partners (Article 8 and Annex C of the SPS Agreement).

# SPS course series 4 - Implementation, Administration and Enforcement (NEW)

In this course, you will learn about institutional and procedural arrangements for the implementation, administration, and enforcement of the SPS Agreement:



- The work of the SPS Committee as a forum for regular consultations and debate on SPS matters (Article 12) (Module 1);
- The resolution of SPS-related trade frictions through different channels, including formal dispute settlement proceedings (Article 11) (Module 2); and
- The provision of technical assistance and granting special and differential treatment for developing countries to facilitate the implementation of the SPS Agreement (Articles 9 and 10) (Module 3).




