## 6. Time and place for takeover (repurchase) of the tender documents

Interested bidder may take over tender documents in the Ministry for Economic Development – Podgorica, Rimski trg 46, from contact persons, each working day, starting from June 11, 2008, from 10.00 to 13.00 hours, or tender documents will be e-mailed to them upon their request.

All bidders that have repurchased tender documents shall have the right to participate.

For collection of tender documents it is necessary to effect payment of the irrecoverable fee in the amount of 1000 (one thousand) EUR, to the giro-account no. 832-978-76, Fee for the repurchase of tender documents – Ministry for Economic Development, with the note: For tender documents under the Invitation number 09/08.

## **7. Time and place of the bids submission**

Bidders submit their bids on every working day from 10.00 to 12.00 hours, by 13.00 hours on September 3, 2008, by direct submission in the Archive Room of the Ministry for Economic Development or by registered mail.

**Comity shall not consider the bids submitted after the expiration of the deadline established in the previous paragraph.**

Bids should be submitted in the sealed envelope marked as “Do not open before the official meeting of the Commission for Opening and Evaluation of Bids”, for the INVITATION number 09/08 – Elaboration of the Spatial Plan of the Area with Special Purpose Bjelasica and Komovi.

## **8. Bid security**

As bid security the bidder is obliged to submit the bank guarantee amounting to 2% of the total value of bid, which shall be valid for the period of 60 days from the deadline determined for submission of bids.

## **9. Time and place of public opening of bids**

Public opening of bids is scheduled for September 3, 2008 at 13.00 hours in premises of the Ministry for Economic Development.

## **10. Deadline for making decision on awarding the contract**

30 days from the opening of bids.

## **11. Changes and amendments of tender documents**

Pursuant to Article 42 of the Public Procurement Law, the Contracting Authority may make changes and amendments of tender documents, not later than five days before the expiry of the deadline determined for submission of bids. Contracting Authority shall notify interested bidders about possible changes and amendments of tender documents.

## **12. Additional information**

Bidder may, in writing, require the additional information or explanation related to the preparation of the bid, no later than five days before the expiry of the deadline determined for submission of bids.

### **13. Security for good realization of the contract**

Pursuant to the provisions of Article 44 of the Public Procurement Law, the first ranked bidder shall be obliged to submit security for good realization of the contract in the amount of 5% of the total value of the bid.
