DECREE

ON CUSTOMS TARIFF FOR 2017

Article 1

This decree shall determine the level of customs duties rates for 2017, in accordance with dynamics established by the Law on Ratification of the Protocol on Accession of Montenegro to the Marrakesh Agreement Establishing the World Trade Organisation (Official Gazette of Montenegro – International Agreements, No 3/12).

Article 2

The customs tariff for 2017 referred to in Article 1 of this decree is given in Addendum which is the integral part of this decree.

The integral part of the Addendum referred to in paragraph 1 of this Decree are Annex 1 – The list of goods for which the customs duty on imports to Montenegro differs from the custom duty given in columns 4 or 5 of the Customs Tariff when imported to Montenegro, Annex 2 – Lists of pharmaceutical products for which abolishment of payment of customs duties is implemented, Annex 3 – The list of goods originating from countries that international agreements have been entered into, for which customs duties are abolished or decreased to the certain level within the framework of individual annual quotas , when imported to Montenegro and Annex 4 – The list of the Least developed countries (LDC) in accordance with the UN classification of the least developed countries, which are granted customs preferences, ie granted zero customs duty rate for goods determined with this decree.

Article 3

The provisions of the law governing foreign trade and of regulations for the implementation of the Customs Law shall apply to granting preferences for products originating from the Least developed countries referred to in Article 2 of this Decree.

Article 4

For the purpose of performing foreign trade activities, additional classifications of the Customs Tariff shall be conducted in the Integrated Customs Tariff of Montenegro (TARICG).

Article 5

This Decree shall enter into force on the eighth day of its publishing in the Official Gazette of Montenegro.
