### III Public procurement subject

#### VI Terms for participation and suitability requirements for Bidders

Mandatory requirements for taking part in the public tender procedure

Public procurement procedure may be taken part into only by the Bidder that:

- 1) is registered to carry out the business activity that is the subject of the public contract;
- 2) is licensed (holds a license or other document) to carry out the activity that is the subject of the public procurement contract, in line with the law;
- 3) has duly met all the liabilities in respect of tax and contributions in line with the law or regulations of the state of its registered office;
- 4) has not been convicted for a criminal act or imposed the measure of injunction related to the criminal act in the period of two years prior to announcement of the public invitation to tender, or submission of the invitation to tender.

Evidence of fulfilment of the mandatory requirements referred to in item VI sub-items 1 to 4 of this Form shall be submitted in the form envisaged in Article 66 and 74 of the Public Procurement Law, as follows:

- 1) evidence of registration with the authority competent for registration;
- 2) permits, licenses, approvals, or other acts in line with the law. (In line with Article 4 paragraph 2 of the Rulebook on the methodology of expressing sub-criteria into relevant number of points, the method of bid evaluation and comparison, the Contracting Authority addressed the Environmental Protection Agency, which stated in its document number: 2270/2 of 10 October 2012 that the bidders are obliged, in the subject public procurement procedure, to submit the following evidence (permits, licenses, approvals or other documents) in accordance with the Law):
  - evidence on registration in the Central registry of business entities, or an appropriate register of the competent state authority of the country of origin of the foreign legal entity or entrepreneur to carry out activities of developing planning documents, studies and environmental impact analysis.
- 3) certificates by the administrative authority responsible for tax affairs confirming that all liabilities in respect of payment of tax and contributions for the period of 90 days prior to public opening of bids have been duly met;
- 4) confirmation, or other act by the competent authority based on the data from penal records evidence of fulfilment of this requirement may not be older than six months from the date of public opening of bids.

Evidence of fulfilment of the requirements for taking part in the public procurement is submitted as original document, a certified copy or in electronic form in line with the Public Invitation to Tender, Invitation to Tender and Tender Documents.

### Optional requirements for taking part in the public tender procedure

In addition to the mandatory requirements for taking part in the public procurement procedure, the Contracting Authority envisages in the Public Invitation to Tender, Invitation to Tender and Tender Documents that the Bidder needs to prove the fulfilment of optional requirements related to:

1) economic-financial capability (Article 67 of the Public Procurement Law).

The Bidder proves the fulfilment of the requirements related to economic-financial capability by:

- a statement on accounting and financial standing income statement and balance sheet including the auditor's report in line with the law regulating accounting and audit, for the last two years, or the period following the registration;
- relevant bank statement, confirmation or certificate on financial capability of the Bidder;

and

2) <u>professional-technical and human resources capacity</u> (Article 67 of the Public Procurement Law)

(Contracting authority has a right and is authorised to specify types of evidence confirming the technical and human resources capacity in line with Articles 69, 70 and 71 of the Public Procurement Law)

Whether conditions of professional-technical and human resources capacity are met in the public procurement procedure is evidences by submitting one or more evidences, and so as follows:

1) statement technical equipment and capabilities and on capacities the bidder has in terms of delivery of specific services.

If the Bidder fails to submit any of the evidence of eligibility envisaged by the Public Invitation to Tender and Tender Documents, their Bid shall be rejected as irregular.

#### X Review, purchase and take over of Tender Documents.

Interested parties are entitled to review and purchase Tender Documents as of the date of announcing the Public Invitation to Tender.

Tender Documents may be reviewed every business day from 10 to 15h, starting from 12 June 2013 to 22 July 2013 (inclusive), at the address Rimski trg 46 in the Ministry of Economy, with the authorised person – Mr. Radosav Čović.

### XI Deadline and place for submission of bids

The Bids are to be submitted on business days from 10 to 15h, 22 July 2013 at 12 o'clock (inclusive), personally to the mailroom of the Contracting Authority, at the address Rimski trg 46, Podgorica.

Bids may also be submitted electronically (in accordance with the Electronic Signature Law and the Electronic Commerce Law), or via registered mail with certificate of receipt.

A duly submitted bid is a bid delivered within the timeframe specified in the Public Invitation to Tender and Tender Documents.

#### XII Time and place for public opening of bids

Public opening of bids, which may be attended by authorised representatives of Bidders holding proxies signed by authorised persons at hand will take place on 22 July 2013 at 13h in the Ministry of Economy, Rimski trg 46, in Podgorica.

XIII Deadline for passing the decision on selection of economically most advantageous bid or cancellation of the public procurement procedure is 22 August 2013.

This deadline is conditional and depends on possible complaints by bidders concerning the legality of the procedure. In the event the legality of the procedure is challenged (appeal lodged), this deadline will be extended in accordance with the Public Procurement Law.

#### XIV Legal remedy

If they find that the Public Invitation to Tender violates their rights or interests related to the rights, actively registered parties may file a complaint to the State Commission for Public Procurement Procedure Control within 10 days from the date of announcing the Public Invitation to Tender

### XX Additional information

Subject of the public procurement is not subject to VAT payment based on the Instruction on the Manner of Conduct of the Procedure Related to Exercising the Right to Exemption From Payment of the Value Added Tax in Cases Provided for in International Agreement or Treaty

(Official Gazette of the Republic of Montenegro, No 34/03).

Having in mind that the amount of estimated value of the public procurement, set forth in item III of this Invitation, is not subject to VAT, the bidders shall be obliged to state the price in their (financial) bid as follows:

- Offered priced (net)
- Discount (if applicable)
- VAT 0 (zero)
- Total offered price (net price with possible discount)

In order to protect against insufficiently serious bids, the Bidder is to submit a Bid Guarantee in the amount of 2% of the estimated value of the public contract, as a guarantee of remaining bound by their bids during the validity period. The validity period of the Guarantee should be 60 days from the final deadline for bid submission.

- Bank guarantee needs to packed in a special PVC two-layer foil perforated on one side and bound with single band with other evidence mage the integral part of the bid.
- Plastic foil wherein the bank guarantee is located should be sealed by a stamp wax.

Performance guarantee in the amount of 10 % of the Contracted Price must be submitted by the first-ranked bidder.

According to item XIX of the Instructions to Bidders, when submitting bids, the Bidders are to enclose all the Tender Documents to the Bid, which had been purchased from the Contracting Authority /hard copy/ numbered, certified and bound in the manner specified in Article 76 of the Law on Public Procurement
