REPORT ON THE CENTRAL GOVERNMENT DEBT AS OF 31 MARCH 2020

Total Central Government debt (deposits not included) as of 31 March 2020, was 3,343.46 million EUR or 72.57% of GDP¹. Total Central Government Debt, including deposits, as of 31 March 2020 was 3,180.33 million EUR or 69.03% of GDP.

The foreign debt was 2,807.84 million EUR or 60.94% of GDP, while the domestic debt was 535.61 million EUR or 11.63% of GDP. At the end of the first quarter of 2020, deposits was 163.13 million EUR or 3.54% of GDP.





During the first quarter of 2020, the Government disbursed the amount of 10.75 million EUR for the needs of the implementation of infrastructure and development projects. From the mentioned amount, 4.34 million USD (3.93 million EUR)² was disbursed from the loan with Exim China Bank for the Project of financing the construction of the first section of the Highway Bar-Boljare; Smokovac-Mateševo.

During the first quarter of 2020, the Central Government Debt repayment of principal was in the total amount of 421,95 million EUR, out of which 79,79 million EUR referred to repayment of debt to residents, including 37,9 million EUR for refinancing of Treasury bills. Repayment of debt to non-residents was 342,17 million EUR. Interest has been repaid in total amount of 36,96 million EUR, out of which 0,98 million EUR referred to repayment of interest to residents, while 35,98 EUR million was paid to non-residence. During the first quarter of 2020, repayment of old currency savings debt was 0,11 million EUR.
